2. Behind the Meter Generation

Terri Esterly reviewed the Problem Statement and Issue Charge addressing clarifications to the Behind the Meter Generation business rules related to a BTMG unit changing status from BTMG (netting against the load) to a resource participating in PJM Markets (and vice versa).

The committee approved the problem statement and issue charge by acclamation with 0 objections and 0 abstentions.

3. Biennial Review of Manual 15

Gabrielle Genuario and Roger Cao reviewed updates to Manual 15: Cost Development Guidelines as part of the Biennial Review.

The committee endorsed the Manual 15 revisions by acclamation with 0 objections and 0 abstentions.

4. Manual 18 Updates

Jeff Bastian reviewed the Problem Statement and Issue Charge addressing a minor correction to Manual 18: Capacity Market with regards to an effective date for notifying pseudo-tied resource owners of their assigned LDA prior to each delivery year. The issue was proposed using the Quick Fix process outlined in Section 8.6.1 of Manual 34: PJM Stakeholder Process.

The committee approved the Manual 18 problem statement and endorsed the Manual 18 revisions with 149 (78%) in favor, 43 (22%) opposed and 21 abstentions.

First Readings

5. Fuel Cost Policy Enhancements

A) Bhavana Keshavamurthy provided a first read of the PSEG proposal addressing Key Work Activity 4 of the Fuel Cost Policy Enhancements Issue Charge.

B) Catherine Tyler, Monitoring Analytics, presented the IMM's comments.

Stakeholders requested clarity on what the MIC will be asked to vote upon since there are no manual or tariff revisions required by the proposal. Ms. Keshavamurthy clarified that the committee will be asked to approve the proposed solution to create a cost-based offer calculator and sending the work of developing the implementation details to the Cost Development Subcommittee.
