



Market Implementation Committee (MIC) WebEx Only March 10, 2021 9:00 a.m. – 4:00 p.m. EPT

Administration

Nick DiSciullo reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and the WebEx Participant Identification Requirements.

The Committee approved the draft minutes from the February 10, 2021 Market Implementation Committee meeting with **0 objections and 0 abstentions**.

Nick DiSciullo provided an update on the MIC Work Plan, which included pending issue charges.

Endorsements/Approvals

2. RPM Capacity Transfer Rights

Kevin Zemanek, Buckeye Power reviewed the Problem Statement and Issue Charge addressing RPM Capacity Transfer Rights. Stakeholders provided feedback on the Issue Charge and revisions were made to the Key Work Activities and Scope section during the meeting to more clearly reflect the scope of the Issue Charge. Kevin Zemanek accepted the revisions, and therefore they were incorporated into the Issue Charge. A post-meeting version of the Issue Charge containing the revisions has been posted to the meeting materials.

The committee approved the RPM Capacity Transfer Rights Issue Charge with the revisions with 185 (79%) in favor, 48 (21%) opposed, and 9 abstentions.

3. Long-Term 5-Minute Dispatch & Pricing Work Plan

Aaron Baizman provided a second first read of the PJM/IMM proposal from the Long-Term Five Minute Dispatch & Pricing Matrix that was worked in MIC Special Session meetings. A draft version of associated OA language was posted with meeting materials for informational purposes.

The committee endorsed the proposal with 210 (100%) in favor, 0 (0%) opposed, and 7 abstentions.

A second vote showed stakeholders preferred the proposal over status quo with 211 (100%) in favor, 0 (0%) opposed, and 9 abstentions.

4. Manual 11 Revisions

Nikki Militello reviewed updates to Manual 11: Energy & Ancillary Service Market Operations as part of the biennial cover-to-cover review.

The committee endorsed the Manual 11 revisions with 177 (100%) in favor, 0 (0%) opposed, and 1 abstention.





5. Capital Recovery Factor for Avoidable Project Investment Cost Determinations

Jeff Bastian reviewed the Problem Statement and Issue Charge addressing Capital Recovery Factor for Avoidable Project Investment Cost Determinations. The issue was proposed using the Quick Fix process outlined in Section 8.6.1 of Manual 34: PJM Stakeholder Process.

The committee approved the issue charge and endorsed the solution with 191 (100%) in favor, 0 (0%) opposed, and 2 abstentions.

A second vote showed stakeholders preferred the proposal over status quo with 180 (100%) in favor, 0 (0%) opposed, and 2 abstentions.

Jim Davis, Dominion Energy, provided a first read of the Problem Statement and Issue Charge addressing Compensation for Reactive Supply and Voltage Control service. The committee will be asked to approve the issue charge at its next meeting.

7. New Load Locating Behind the Meter of an Existing Generation Resource

Jeff Bastian provided a first read of the Problem Statement and Issue Charge addressing New Load Locating Behind the Meter of an Existing Generation Resource. Stakeholders requested additional clarity on the Problem Statement the Issue Charge aims to address before voting on it. Jeff Bastian agreed to refine the Problem Statement in advance of the next meeting. The committee will be asked to approve the issue charge at its next meeting.

 - a) Stefan Starkov provided an overview of PJM's proposed solution options and reviewed the Market Suspension scenario table.
 - b) Lisa Morelli facilitated a discussion on the Market Suspension matrix as part of the Consensus Based Issue Resolution process.
