#### 1. Administration

Ms. Lisa Morelli called the meeting to order and welcomed stakeholders. Ms. Morelli reviewed the agenda and called attention to the Anti-trust and Code of Conduct statements. Ms. Cheryl Mae Velasco performed roll call and reviewed the draft meeting minutes from the 7/7 ERPIV meeting. The minutes were approved.

# 2. Review Workplan

Ms. Morelli reviewed the draft workplan. With the aggressive timeline, the group is looking to schedule an additional meeting in August before presenting the proposals to the standing committees. However, no date has been selected yet. No other requests for changes were made.



#### 3. Education

Ms. Rebecca Carroll provided the group with an overview of Coordinated Transaction Scheduling to provide background for the interchange volatility discussions.

#### 4. Review of PJM Interchange Volatility Solution Components and Options

Ms. Carroll presented PJM's proposed solution for the interchange volatility component of the issue charge. PJM proposes a new optional Real-Time transaction product that is economically evaluated during periods where a hot/cold weather alert, max emergency generation alert, or other emergency is in place. PJM also spoke to having an interchange limit and how to treat uplift charges, however details surrounding these topics are still under internal discussion.

#### 6. Review of Interchange Volatility Alternate Solution Components and Options

Mr. Dave Scarpignato, Direct Energy, and Mr. Louis Slade, Dominion, reviewed an alternate proposal that was brought forth by a group of stakeholders that met separately called the New Reserve Product Coalition. The group proposed a solution to interchange volatility that aligned closely with PJM's proposal, with a few differences. PJM and the Coalition plan to work together to attempt to combine the proposals and work out the details together.

#### 8. Energy/Reserve Pricing Solution Components and Options Development

Mr. Adam Keech and Mr. Angelo Marcino provided additional detail surrounding the PJM proposal of a new 30 minute reserve market. Information was provided on the determination of the penalty factor, how the requirement would be calculated, how the 30 minute reserves would be nested among the existing reserve products, and other pricing impacts. An example was provided to show the potential pricing impacts and settlements for the proposed solution. Mr. Scarpignato and Mr. Slade provided a similar example to showcase the difference between the PJM proposal and the alternate proposal. A request for additional examples was made and will be provided at a future meeting.
