Special MIC – Distributed Energy Resources (DER) PJM Conference and Training Center May 19, 2017 1:00 p.m. – 4:00 p.m. EST

Administration

- 1. Mr. Baker called the meeting to order, reviewed the agenda and asked for amendments to the agenda.
- 2. Mr. Gledhill reviewed meeting participation guidelines and the minutes from the April 10th meeting. Attendance was taken offline from a combination of in-person and WebEx attendees.

Behind-the-Meter Visibility

3. Mr. Ford provided background on existing PJM processes and initiatives, including discussion of *PJM Manual 3A: Energy Management System (EMS) Model Updates and Quality Assurance (QA) - Appendix D*. This initiated a dialog with the subgroup for resources not in the DR market or Generation Interconnection Queue <u>and</u> the reporting process for Non-Retail Behind the Meter Generation and retail behind the meter generation.

Consensus Based Issue Resolution Process

4. Mr. Levitt led a discussion of design component 2 (method to serve retail on-site load with DER output and associated accounting), showing various one-line configurations for discussion. Through discussion, clarity was requested on establishing accounting responsibilities: 1) who determines the metering accounting method; 2) who adminsters the method; 3) who owns the necessary equipment. Discussion will continue at the June 1, 2017 meeting.

5. Mr. Baker summarized action items and adjourned the meeting.
