



Market Implementation Committee PJM Conference and Training Center October 4, 2023 9:00 a.m. – 2:35 p.m. EPT

Administration (9:00 - 9:05)

Amanda Martin, PJM, reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and WebEx Participant Identification Requirements.

The committee approved the draft minutes from the September 6, 2023 Market Implementation Committee meeting.

Endorsements/Approvals (9:05 – 10:15)

1. <u>Performance Impact of the Multi-schedule Model on the Market Clearing Engine (9:05 – 9:25)</u> Foluso Afelumo, PJM, solicited any questions or feedback on the packages.

The committee endorsed the following packages:

- PJM Package (A) with 153 (77%) in favor, 45 (23%) opposed, and 17 abstentions. A second vote showed stakeholders preferred the PJM Package A over status quo with 153 (77%) in favor, 45 (23%) opposed, and 37 abstentions.
- PJM/GT Power Package (B) with 144 (66%) in favor, 75 (34%) opposed, and 15 abstentions. A second vote showed stakeholders preferred the PJM/GT Power Package (B) over status quo with 148 (68%) in favor, 70 (32%) opposed, and 15 abstentions.

The committee did not endorse the following packages:

- IMM/GT Power Package (C) with 34 (15%) in favor, 186 (85%) opposed, and 15 abstentions. A second vote showed stakeholders preferred the IMM/GT Power Package (C) over status quo with 34 (15%) in favor, 186 (85%) opposed, and 15 abstentions.
- IMM Package (D) with 14 (7%) in favor, 185 (93%) opposed, and 15 abstentions. A second vote showed stakeholders preferred the IMM Package (D) over status quo with 14 (7%) in favor, 184 (93%) opposed, and 15 abstentions.
- IMM2 Package (E) with 13 (7%) in favor, 185 (93%) opposed, and 15 abstentions. A second vote showed stakeholders preferred the IMM2 Package (E) over status quo with 13 (7%) in favor, 185 (93%) opposed, and 15 abstentions.

The PJM Package (A) will move to the Markets & Reliability Committee as the Main Motion. The PJM/GT Power Package (B) will move to the Markets & Reliability Committee as the Alternate Motion.

The committee endorsed the PJM/E-Cubed/IMM package by acclamation with 0 objections and 0 abstentions. Stakeholders also showed preference for the PJM/E-Cubed/IMM package over the status quo by acclamation with 0 objections and 0 abstentions.

The committee approved the issue charge with 221 (96%) in favor, 10 (4%) opposed and 17 abstentions.
