



- CMP members continues to meet on a regular basis working through Freeze Date data analysis
  - Next CMP working group meeting 5/09/24
  - Next CMP Council meeting 6/19/24
- MISO IMM discussed position on MISO FFE Counterproposal at 3/14 CMP meeting
- PJM/SPP IMM provided comment
  - MISO/PJM/SPP IMM agreed to continue discussions



- Other Areas of Focus in CMPWG
  - Firm Flow Limit Update
    - TVA providing additional analysis
  - FERC Order 881 impacts to Flowgate Allocation
  - Energy Storage Resource Considerations in Market Flow calculation
  - Review Current Transmission Upgrade Study Process

  - 0 new PAR coordinated flowgates added or retired
  - 0 new M2M flowgates added or retired

- JOA activities with southern neighbors continue to perform well
- Winter Recap / Summer Readiness meetings being planned

- PJM – MISO Interregional Stakeholder Advisory Committee Annual Issues Review
  - Existing and new regional issues along PJM/MISO seam
  - Newly approved projects near PJM/MISO seam
  - M2M historical congestion
- Joint RTO Planning Committee
  - Within 45 calendar days after the Issues Review IPSAC the JRPC shall determine the need for a Coordinated System Plan study

- Targeted Market Efficiency Project (TMEP) Study
  - MISO and PJM opted not to perform a TMEP Study in 2023 based on limited 2021+2022 historical M2M congestion drivers.
  - RTOs believed it prudent to assess the impact of planned upgrades and congestion persistence with an additional year of market data before starting on a new TMEP study
  - RTOs are currently reviewing high highest congested elements and potential mitigation factors

- Interregional Market Efficiency Project (IMEP) Study
  - PJM and MISO are coordinating interregional congestion issues for consideration in the 2024 PJM-MISO CSP planning cycle
- Interregional Reliability Projects; Interregional Public Policy Projects; Ad-Hoc studies
  - No issues currently identified

- Annual Issues Review IPSAC held March 25, 2024
  - 6 Entities provided feedback
- JRPC determines whether to perform a CSP study in 2024
  - JRPC will inform IPSAC by May 14, 2024 per JOA
- Next PJM / MISO IPSAC will be scheduled mid-year (tbd)
- PJM / NYISO / NEISO IPSAC meeting scheduled for 5/3/24

The next joint stakeholder meeting will be hosted by PJM on September 13, 2024 via WebEx


