



Markets and Reliability Committee The Chase Center, Wilmington, DE March 21, 2019 9:00 a.m. – 11:50 a.m. EPT

#### Administration (9:00-9:10)

Ms. Suzanne Daugherty and Mr. Dave Anders welcomed stakeholders and provided the Anti-trust and Code of Conduct announcements.

Mr. Stu Bresler discussed the status of the 2022/2023 Base Residual Auction scheduled to be run in 2019. Mr. Bresler noted the FERC finding in that the current rules for the auction are not just and reasonable, and that the FERC has not acted upon PJM's related compliance filing. He discussed potential options including:

- Request that FERC approve a further delay of the auction schedule
- Request that FERC approve executing the auction with existing rules
- Make a Section 205 filing with an alternative rate to be used for this auction only

Mr. Bresler invited stakeholder input and recommendations. Mr. Bresler also solicited feedback regarding PJM's intent to suspend collecting data required to support PJM's proposal at FERC in the MOPR docket.

### **Consent Agenda (9:10-9:20)**

Items A through D were **approved/endorsed** by acclamation with no objections or abstentions.

- A. Draft minutes of the February 21, 2019 meeting of the Markets and Reliability Committee (MRC).
- B. Proposed revisions to Manual 13: Emergency Operations updated to reflect language in the new version of NERC EOP-004-4 and more accurately reflect OE-417 requirements.
- C. Proposed revisions to Manual 20 Resource Adequacy Analysis resulting from a periodic cover-to-cover review, removing outdated references, and updating references to ReliabitlityFirst's standards.
- D. Proposed revisions to Manual 37: Reliability Coordination resulting from a periodic cover-to-cover review and incorporating an updated Appendix D.

### Endorsements/Approvals (9:20-10:00)

### 1. Deficiency Cure Periods (9:20-9:30)

Ms. Susan McGill presented updates to Manual 14A: New Services Request Process and the OATT associated with deficiency cure periods at the end of the queue and identify potential areas of improvement. Following discussion the committee **endorsed** the proposed revisions by acclamation with no objections or abstentions.





### 2. Fuel Security Problem Statement and Issue Charge (9:30-10:00)

Mr. Tim Horger reviewed the proposed Fuel Security problem statement and issue charge, including the posted "compromise" update. Mr. Erik Heinle, DC Office of the Peoples' Counsel, discussed the proposed alternate Energy Security problem statement and issue charge, noting that PJM had addressed their concerns in the proposed compromise update. Mr. Heinle withdrew the proposed alternate problem statement and issue change.

Ms. Marji Philips, Direct Energy, proposed a friendly amendment to change the Expected Duration of Work Timeline as follows:

The activities of the group are expected to begin in April 2019, and be completed by the end of 2019. By the end of the 3rd quarter 2019 the group will complete key work activities #1 - #3 and expected deliverable #1 and will report to the MRC their recommendations. The remainder of the key work activities and deliverables will be completed by the end of 2019. At that time the MRC will establish the timeline for completion of the remaining work activities and deliverables to be completed no later than June 1, 2020. This will be a high priority issue and will meet a minimum of once per month.

Mr. Horger indicated that this was considered friendly, and therefore it was incorporated into the proposed issue charge.

Mr. Bob O'Connell, Panda, moved an alternate issue charge which added/modified the following Key Work Activities:

- Quantify via study the probability of occurrence of any scenario that might present a risk of fuel insecurity.
- 6. Analyze and quantify the market responses to any conditions that could lead to fuel insecurity identified in 4 above
- 7. Assess whether is the current market construct is sufficient to cure the energy/fuel insecurity identified in 4 above.
- 9. Determine and compare potential mechanisms, including costs, to ensure and value fuel/energy security and their associated costs and benefit to cost ratio in PJM and consider recommendations from relevant studies and assessments that are technically feasible.

Mr. O'Connell's proposed alternate issue charge modified the Deliverables as follows:

- 1. A recommendation to the MRC on whether market or operational changes are needed to ensure current or future fuel/energy security if any are needed.
- 3. Revisions to the Operating Agreement, Open Access Transmission Tariff, and manuals to implement the recommended enhancements if any are needed.

Additionally, Mr. O'Connell's proposed alternate issue charge modified the Expected Duration of Work Timeline as follows:

The activities of the group are expected to begin in April 2019, and be completed by the end of August of 20202019. By the end of the 3rd quarter 2019 the group will complete key work activities





#1 - #3 and expected deliverable #1 and will report to the MRC their recommendations. The remainder of the key work activities and deliverables will be completed by the end of 2019. This will be a high priority issue and will meet a minimum of once per month.

Ms. Daugherty ruled that the motion was out of order, as problem statements and issue charges may be offered by a Member, PJM or the IMM without a motion or second being required by a Member. She added that Mr. O'Connell's proposed issue charge could be offered as an alternate motion that would be voted upon should the compromise motion fail. Mr. O'Connell moved and Ms. Ruth Price seconded an appeal of the decision of the Chair. Following discussion the appeal of the decision of the Chair failed in a sector-weighted vote with 0.98 in favor.

Mr. David Scarpignato, Calpine, proposed a friendly amendment to change "Fuel/Energy" to Fuel/Energy/Resource" throughout both the proposed compromise issue charge. Mr. Horger and Mr. Heinle indicated that this was considered friendly, and therefore it was incorporated into the proposed compromise issue charge.

Mr. Horger presented an updated compromise issue charge incorporating the elements of the original compromise issue charge and Mr. O'Connell's proposed alternate issue charge. He indicated that this had the support of PJM. Mr. Heinle and Mr. O'Connell also indicated their support.

Following discussion the committee <u>approved</u> the proposed problem statement and updated compromise issue charge by acclamation with one objection and one abstention.

### 3. PJM Manuals (10:00-10:20)

- A. Ms. Andrea Yeaton reviewed updates to Manual 11: Energy & Ancillary Services Market Operations due to addition of location fields in DR Hub. The committee will be asked to endorse these revisions at its next meeting.
- B. Ms. Susan Kenney reviewed updates to Manual 11: Energy & Ancillary Services Market Operations as part of the biennial review. The committee will be asked to endorse these revisions at its next meeting.
- C. Mr. Jerry Bell and Patricio Rocha-Garrido presented proposed revisions to Manual 21: Rules & Procedures for Determination of Generating Capability, including the revisions from the recent ELCC Analysis discussions. The committee will be asked to endorse these revisions at its next meeting.

### 4. Must Offer Exception Process (10:20-10:45)

- A. Mr. Pat Bruno provided a second first read of the MRC main motion for the Must Offer Exception Process and provided a update of Market Implementation Committee (MIC) activities.
- B. Ms. Sharon Midgley, Exelon, reviewed an alternate proposal endorsed by the MIC at its March meeting.





The committee will be asked to endorse the main motion and any alternate proposals at its next meeting.

- 5. PJM Transmission Service and Merchant Facility Business Practices Update (10:45-10:55)
  - A. Mr. Chris Advena provided a first read on the revisions to the PJM Regional Business Practices document associated with the new OASIS application. The committee will be asked to endorse these revisions at its next meeting.
  - B. Mr. Advena also provided an informational update on the corresponding changes to the Merchant Facilities Practices document also associated with the new OASIS.
- 6. Market Efficiency Process Enhancement Task Force (10:55-11:05)

Mr. Brian Chmielewski presented the Market Efficiency phase 2 proposal developed at the Market Efficiency Process Enhancement Task Force (MEPETF) and the associated proposed Manual and Operating Agreement revisions. The Committee will be asked to endorse the proposal and proposed revisions at its next meeting.

### 7. FTR Forfeiture Hourly Component (11:05-11:20)

Mr. Brian Chmielewski provided a first read to address an issue identified in the FTR Forfeiture hourly cost component calculations. The proposed solution will also be presented. The committee will be asked to endorse these revisions at its next meeting.

### 8. Carbon Pricing Problem Statement / Issue Charge (11:20-11:35)

Mr. Michael Borgatti, Gable Associates, presented a proposed problem statement and issue charge related to carbon pricing. The Committee will be asked to endorse these documents at its next meeting.
