Endorsements/Approvals

1. Surety Bonds

Kathleen McElwaine provided a review of the surety bonds proposals as deferred at the April 25, 2019 Markets and Reliability Committee meeting. Following discussion, the committee **endorsed** the proposal and associated Tariff revisions by acclamation with three objections and three abstentions.

2. PMA Credit Requirements

Bridgid Cummings reviewed proposed Tariff revisions related to Peak Market Activity (PMA) credit requirements pertaining to federal, state, and/or local law transfer of charges or credits. Following discussion, the committee **endorsed** the proposal and associated Tariff revisions by acclamation with no objections and one abstention.

3. Integration of HVDC Converter Problem Statement

Steve Frenkel, SOO Green, reviewed a proposed Problem Statement and Issue Charge seeking an opportunity to integrate High Voltage Direct Current (HVDC) converters as a new type of capacity resource. Following discussion, the committee **approved** the proposed Issue Charge in a sector-weighted vote with 4.40 in favor.

4. Transparency and End Of Life Planning

Jim Gluck reviewed the work completed at the MRC Special Sessions for Transparency and End of Life Planning including proposed solutions.

- A. Mark Ringhausen, Old Dominion Electric Cooperative, Lisa McAlister, AMP, and Mike Engleman on behalf of LS Power, reviewed the joint stakeholder solution proposal and draft OA revisions posted.
- B. Dave Souder reviewed PJM's solution proposal.

Following discussion, both proposals **failed** in sector-weighted votes, with the joint stakeholders' proposal receiving 3.23 in favor and the PJM proposal receiving 1.77 in favor. Stu Bresler noted that while the agenda for the May 28, 2020 Members Committee meeting indicated that endorsement/approval will be sought on the same day that would not happen as a matter of course.
