X. Manual 11: Energy & Ancillary Services Market Operations – Implementation of Fast Start Pricing

Greg Poulos, CAPS, requested removal of Manual 11: Energy & Ancillary Services Market Operations to address the implementation of Fast Start Pricing to facilitate a separate vote. Greg Poulos, on





behalf of the New Jersey Division of Rate Counsel, moved and Erik Heinle, Office of the People's Counsel for the District of Columbia, seconded deferring vote on the proposed revisions to the September 29, 2021 MRC meeting. The motion to defer <u>failed</u> in a sector-weighted vote with 2.08 in favor. Following discussion, the proposed revisions were <u>endorsed</u> in a sector-weighted vote with 3.41 in favor.

Steve Pincus reviewed a proposed solution to make cure periods uniform across the Tariff and OA. Following discussion, the committee **endorsed** the proposed revisions by acclamation with no objections or abstentions.
