1. Synchronized Reserve Requirement for Reliability





- A. Donnie Bielak and Phil D'Antonio discussed the increase of the synchronized reserve requirement to meet reliability standards and corresponding revisions to Manual 11: Energy & Ancillary Services Market Operations, Section 4.3 and Manual 13: Emergency Operations, Section 2.2.
- B. Joe Bowring, Monitoring Analytics, presented perspectives as to the synchronized reserve requirement.

Following discussion, the proposed Manual revisions <u>failed</u> endorsement in a sector-weighted vote with 2.3 in favor. Stu Bresler confirmed that the revisions will be incorporated into the Manuals as proposed under PJM's right and responsibility for PJM Manuals as captured in Manual 34, Section 11.15 and Operating Agreement, Section 10.4.iii.

Skyler Marzewski presented a proposed solution and corresponding Tariff revisions related to calculating the smooth supply curves for the Base Residual Auctions. The committee will be asked to endorse the proposed solution and corresponding Tariff revisions at its next meeting.
