- 1. Performed roll call.
- 2. Mr. Dave Souder, PJM, discussed the proposed changes for Manual 13: Emergency Operations and solicited feedback from stakeholders. Mr. Souder also shared the proposed manual endorsement timeline for first readings at the June 11 OC meeting and an endorsement vote at the July 9 OC meeting.
- 3. Ms. Terri Esterly, PJM, reviewed proposed language changes for Manual 14D: Generator Operational Requirements, Appendix A and solicited feedback from stakeholders.
- 4. Ms. Terri Esterly, PJM, reviewed the proposed data collection template and solicited feedback from stakeholders. PJM plans to release an updated data collection template which incorporates stakeholder feedback ASAP following the June 11 OC meeting. PJM provided a definition of terms in the template.
- 5. Mr. Souder requested that stakeholders provide any proposed language changes to the M-13 and M-14D redline versions by June 7. Additionally, Mr. Souder notified the subgroup that a preliminary review of the proposed M-13 and M-14D language changes with the PJM Tariff indicate that no PJM Tariff changes are required. If the need for PJM Tariff changes are identified the proposed changes will be presented at future OC meetings.
- 6. Meeting was adjourned at 2:29 p.m.

- 1. PJM will review wording regarding "highest net performance" for impacts on Max Emergency and constraint control on NRBTMG resources.
- 2. Stakeholders will provide any proposed revisions to M-13 and M-14D manuals by Friday, June 7 at noon.
- 3. PJM will release the proposed data collection template ASAP following the June 11 OC meeting.
