

April Planning Committee Teleconference / WebEx April 12, 2022 9:00 a.m. – 12:00 p.m. EPT

Administration (9:00 – 9:15)

- 1. Dave Souder, PJM, called the meeting to order. Marilyn Jayachandran, PJM, reviewed the Antitrust, Code of Conduct, media participation, and WebEx guidelines.
- 2. Marilyn Jayachandran reviewed the April 12, 2022 Planning Committee agenda. No changes to the agenda were requested.
- 3. Marilyn Jayachandran reviewed the draft March 8, 2022 Planning Committee meeting minutes and the committee approved the draft minutes from the March 8, 2022 PC meeting.
- 4. Dave Anders, PJM, provided an update on the voting protocols for Board elections at the May Members Committee meeting.
- 5. Marilyn Jayachandran reviewed the 2022 PC Work Plan.

Endorsements (9:15 – 9:45)

- Manual 14F: Competitive Planning Process Update Joseph Hay, PJM, provided a review of Manual 14F regarding the biennial cover-tocover review. The committee approved the Manual 14 F changes with 0 objections and 0 Abstentions.
- 7. <u>Manual 21A: Determination of Accredited UCAP Using Effective Load Carrying</u> <u>Capability Analysis</u>

Joshua Bruno, PJM, provided a review of Manual 21A revisions regarding an ELCC model run timing update and changes to reflect the continuation of the current method to provide unit specific backcasts only as requested. There were no changes reported since the March first read.

The committee approved the Issue Charge and endorsed the proposed Manual 21A revisions as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at today's meeting. There were 182 Yes votes, 5 No Votes, and 9 Abstentions. The committee also approved the proposed solution over the status quo with 182 Yes votes, 5 No Votes, and 9 Abstentions.
