- PJM Preliminary Response to the Extreme Weather NOPR
 Sami Abdulsalam, PJM, provided background and preliminary thoughts on PJM's perspectives on the Extreme Weather NOPR. The topics discussed included
 - a. Development of benchmark planning cases based on information such as major prior extreme heat and cold weather events or future meteorological projections
 - b. Planning for extreme heat and cold events using steady-state and transient stability analyses expanded to cover a range of extreme weather scenarios
 - c. Corrective action plans that include mitigation for any instances where performance requirements for extreme heat and cold events are not met.
