## 1. ADMINISTRATION

The Subcommittee approved the minutes of the July 18, 2014 meeting by acclamation with no objections and no abstentions.

## 2. VARIOUS ISSUES UPDATE

Mr. Loomis provided an update on the following issues:

- A. Risk Policies
- B. Virtual Transactions Credit Requirement Timeframe
- C. Demand Bid Screening
- D. PMA Exclusions

### 3. FRIENDLY AMENDMENTS

The following friendly amendments were approved by consensus with no objections or abstentions and will be presented for endorsement at the MIC in September:

- A. Exclude export transactions from the PMA calculation.
- B. Reduce export credit requirement timeframe from four days to two days.

#### 4. FTR ANALYSIS

Mr. Loomis indicated that data for the FTR Undiversified exposure analysis had been received but the analysis had not commenced due to resource limitations.



#### 5. VIRTUAL TRANSACTIONS POLAR VORTEX IMPACT

Per stakeholder request, Mr. Loomis led a discussion on the Jan/Feb 2014 market prices and their impacts on the Jan/Feb 2015 virtual transactions credit requirements. He stated that the Jan/Feb 2015 virtual transactions credit requirements would be approximately ten times higher than those for Jan/Feb 2014, though only about four times higher than other timeframes in the past. Several Members expressed a desire to make a temporary change to the credit requirements for Jan/Feb 2015. They also wanted to expedite the process for such a change and would like comments from the Market Monitor. Mr. Loomis stated that such a change would require a tariff change and PJM does not support such a change, but would facilitate discussion by the members in the stakeholder process if so desired. Mr. David Anders, of PJM, indicated that if members wished to expedite the process, they could bring a problem statement and issue charge to the September MIC meeting, and PJM could schedule one or more additional CS meetings as well, if needed.

### 6. NET SELLER CREDIT

Mr. Loomis presented a proposal to remove the net seller credit from the PJM Credit Policy. The proposal was approved by consensus with no objections or abstentions.

#### 7. PMA CREDIT REQUIREMENTS MATRIX

Mr. Loomis led a discussion on potential changes to the PMA credit requirements components in the matrix that was discussed at the last meeting, including several items that were offered at that meeting. Members were asked at the meeting to send packages of components to the credit group prior to the September CS 9/29/14 meeting for consideration at that September meeting.
