



DER and Inverter-based Resources Subcommittee WebEx Only May 19, 2021 9:00 a.m. – 4:00 p.m. ET

Administration (9:00 – 9:05)

- 1. Scott Baker, PJM, opened the meeting and reviewed the agenda.
- 2. Hamad Ahmed, PJM, reviewed the meeting participation guidelines. The minutes from the last DIRS meeting were approved with 0 objections and 0 abstentions.

Order 2222 - EDC Coordination Workshop (9:05 - 11:00)

- 3. Distribution utility representatives provided feedback on the PJM straw proposal.
 - a. Chris Wehr, First Energy, and several stakeholders discussed several topics within PJM's straw proposal such as min/max size requirements, Metering, Settlements, double counting, EDC definition, Registration/utility review and Operations coordination.
 - b. Wanda Reder, PPL, discussed Operations coordination within the PJM straw proposal.
 - c. Michelle Farhat, PJM, discussed points on operational model intricacies while reviewing flowchart for base and alternative Operations coordination.
- 4. Stakeholders will work offline with PJM facilitation team to finalize topics for June 11th EDC coordination workshop.

Order 2222 - Straw Proposal (11:15 - 2:00)

- 5. Stakeholders provided feedback on PJM proposal.
 - a. Bruce Campbell, CPower and on behalf of the Advanced Energy Management Alliance, discussed AEMA's comments on PJM's initial DER strawman. Bruce discussed recommendations on issues not addressed by PJM on several topics such as PJM planning requirements, opt-in, location and Operations, weighting factors, Telemetry, Operational needs, Market participation model, min/max size, metering and use cases.
 - b. Catherine Tyler, IMM, presented feedback on the straw proposal. Catherine discussed numerous guiding principles, concerns around nodal DERs and registration process. Catherine provided IMM's feedback on several topics such as Energy Market cost based offers for DERS, participation model, min/max size requirements, DRs in DERA and double counting.
- 6. Scott Baker lead a discussion on draft use cases that will be used to provide additional details about the DERA market participation model using more specific examples. Scott presented four use cases and associated key points. Stakeholders were asked to consider these use cases and provide





additional comments to PJM staff offline. Additional use case discussion will continue at the June 28th meeting.

Solar-Battery Hybrid Resources (2:00 – 3:55)

- 7. Andrew Levitt, PJM, presented PJM staff's position on solar-battery hybrids offering synchronized reserves, and reviewed the PJM proposal in the solutions matrix.
 - a. Andrew reviewed PJM's package regarding Reserves and made modifications to PJM's package for Modeling Energy/Ancillary Services and Resource Classification Process. Andrew stated that PJM will make the rest of the changes offline.
- 8. Jim Davis and Bill Coyle, Dominion, discussed a new solution option under design components 5 Regulation.
 - a. Jim and Bill presented Dominion Energy's new design component for Regulation and reviewed example of solar irradiance running counter to regulation signal. Dominion indicated they may add an additional solution package that includes this solution option.
- 9. Sharon Thomas provided feedback on the proposals on behalf of the Energy Storage Association.
 - a. Sharon provided strong support on definitions and Capacity Market must-offer, preferences on reserve design component, concerns regarding resources classification process and Modeling Energy/Ancillary Services and clarifications on open-loop and closed-loop hybrids.
- 10. Stakeholders discussed decision-making in order to recommend a proposal up to the Markets Implementation Committee (and the Operating Committee) for a first read.
 - a. Scott Baker proposed a tentative timeline for reviewing final proposals at the June DIRS, and if feasible, recommending them to the MIC and OC in July. If not feasible, the proposal(s) will be taken to the MIC and OC in August for a first read.

Action items and next meeting agenda (3:55 – 4:00)

- 11. The facilitation team reviewed action items from the meeting and took requests for future agenda items.
 - a. PJM to evaluate performing an analysis of constraints and frequency of constraints to make informed judgement of the aggregation of pnodes.
