

PJM Affected Systems

- Affected Systems that PJM coordinates with:
 - NYISO
 - MISO
 - LGE-KU
 - TVA
 - Duke Energy Progress (DEP)





Affected Systems Coordination – Present Process

Feasibility Phase:

PJM runs an affected system screen and sends a list of PJM queue projects to potential affected systems for their review.

Facilities Study Phase:

PJM coordinates with affected systems to determine final affected system impacts.







Impact Study Phase:

PJM coordinates with affected systems to determine which PJM queue projects require affected system studies. Include affected system results with Impact Study if available.



Affected Systems Coordination – Proposed New Process

Phase 1:

PJM runs affected system screen and sends a list of PJM queue projects to potential affected systems for their review and feedback.

Phase 2:


- PJM coordinates with affected systems to confirm which PJM queue projects require affected system studies, if not already confirmed in Phase 1.
- If Affected System requires an Affected System Study Agreement, Project Developer will be notified to execute such agreement.

Phase 3:

PJM coordinates with affected systems to determine final affected system impacts.







IC D2:

Affected System Study Agreements, if applicable, required to be executed by the later of IC D2 or 60 days after notification from PJM.



Affected Systems Coordination – Upcoming Items

- PJM Manuals and JOAs to be revised as needed to reflect Tariff language filed with FERC
 - PJM Planning M14 Series manuals
 - MISO JOA, NYISO JOA, Progress JOA, TVA JRCA
- JOA revisions to be done in coordination with each neighbor/affected system.

Affected Systems Coordination – PJM/MISO JOA

- PJM/MISO JOA, for example, some specific details that will need revision:
 - Timing of sharing new PJM queue projects with MISO and receiving MISO affected system results
 - How Queue Priority is established between PJM and MISO queue cycles

Affected Systems Coordination – PJM/MISO JOA

- PJM/MISO Queue Priority (between PJM & MISO cycles)
 - Existing JOA:
 - MISO Performed Affected System Studies
 - MISO Cycle's Application Deadline
 - PJM Cycle's Impact Study Start Date
 - PJM Performed Affected System Studies
 - MISO Cycle's DPP Phase II Completion Deadline
 - PJM Cycle's Impact Study Completion Deadline
- Presently, PJM & MISO establish queue priority differently. Consider establishing queue priority the same way between PJM and MISO affected system studies when reflecting the new PJM queue process.
- Working with MISO on new queue priority language
