



Reliability Standards and Compliance Subcommittee WebEx/Conference Call January 15, 2021 9:00 a.m. – 10:00 a.m. EPT

### Administration (9:00-9:15)

- 1. Monica Burkett introduced new Chair, Monica Burkett, and Secretary, Ashwini Bhat, of RSCS to the sub-committee and thanked past Chair and Secretary for their service.
- 2. Ashwini Bhat and Monica Burkett reviewed Antitrust Guidelines, Code of Conduct, Public Meetings/Media Participation, Webex Participant Identification Requirements.
- 3. Ashwini Bhat reviewed the <u>agenda</u> for the meeting. The agenda was approved with no objections and no abstentions.
- 4. Monica Burkett reviewed <u>minutes</u> from the October 16, 2020 RSCS meeting. The minutes were approved with no objections and no abstentions.
- 5. Tom Foster, PJM, provided a brief update on the realignment of the Compliance group at PJM. Tom indicated that he is the manager for NERC Compliance and Alpa Jani is the manager for Operational Excellence & FERC Compliance.

### **PJM Compliance Activities (9:15-9:45)**

- 6. Manual Updates
  - A. Kevin Hatch, PJM, provided an <u>update</u> on Manual 13. He provided a summary of proposed language for Manual 13 along with the endorsement timeline. Presentations are available from the January OC meeting: <u>Executive Summary</u>, <u>Presentation</u>, <u>Redline</u>.
    - a. OC First Read: December 3, 2020
    - b. OC Endorsement: January 13, 2021
    - c. MRC First Read: December 17, 2020

    - e. MRC Voting Date: January 27, 2021
- 7. Monica Burkett, PJM, reviewed the 2021 RSCS schedule. She mentioned that the schedule is subject to change and all participants will be notified of any changes in future RSCS meetings.





- 8. Tee LaRosa, PJM, provided the <u>Transmission Owner Contact updates</u>. He requested Generator Operations, Distribution Providers, Transmission Owners and Transmission Operations to document the contact list and asked to report any errors and gaps to be sent to <u>regional\_compliance@pim.com</u>.
- 9. Mark Kuras, PJM, and Stanley Sliwa, PJM, provided an update on Requirement R10 of PRC-006-3 which requires each Transmission Owner to provide automatic switching of its existing capacitor banks, Transmission Lines, and reactors to control over-voltage as a result of under frequency load shedding if required by the UFLS program. They indicated that in the past PJM maintained a document titled "PJM NERC PRC-006-2 Automatic Under frequency Load Shedding Program" which covered the various requirements including R10 indicating that PJM's current UFLS program does not require automatic switching of Transmission Owner capacitor banks, Transmission Lines, and reactors to control over-voltage as a result of under frequency load shedding. Going forward, PJM is planning to retire this document and instead move this language into Manual 36 Attachment H
- 10. Mark Kuras provided an update on the PJM CIP-002 and CIP-014 2021 IROL Letters. He mentioned to expect the IROL letters before June of 2021 due to its dependency on the OATF study.
- 11. Mark Kuras presented the <u>proposed changes</u> to the TO/TOP Matrix. He indicated that <u>TO/TOP Matrix V15</u> is an effective tool fundamental to a strong PJM internal control. Mark Kuras also discussed TO/TOP Matrix update process and changes incorporated in V15. TO/TOP Matrix V15 will be effective on April 1, 2021.

## FERC, NERC, and Regional Activities (9:45-9:55)

- 12. Elizabeth Davis, PJM, provided an update on FERC, NERC and regional activities.
  - A. She discussed FAC-008-5(Standards Efficiency Review retirements), MOD-026-1 and MOD-027-1 standards (Verifications of Models and Data for Generators SAR).
  - B. Elizabeth indicated that Project 2019-04 Modifications to PRC-005-6 Standard Authorization Request, formal comment period is open through February 12, 2021.
  - C. She stated that NERC Draft Reliability guidelines were posted through email and all comments are due by February 1, 2021.
  - D. Elizabeth mentioned that registration is open for 2021 RISC Reliability Leadership Summit to be held on January 26 and 27 of 2021.
  - E. She also indicated that NERC filed with FERC a petition for approval of an errata to Standard FAC-001 and mentioned that the next Reliability First Technical talk is on January 25, 2021.
