### **CAPSTF** Background

- Issue Charge approved at April 2022 MRC
- 13 meetings between June 2022 May 2023
- Extensive discussion and analysis on conceptual market designs associated with clean energy/attribute procurement mechanisms.
  - Final analysis results
- Three draft solution packages developed: matrix



### **Summary of Solution Packages**

Package A: Forward Clean Energy Market (FCEM)

2 regionally-defined unbundled attribute products

**PJM-REC (MWh):** PJM region-wide renewable energy certificate (PJM-REC). Unbundled from energy. Eligible technologies: renewable resources in PJM footprint that are most broadly eligible under PJM states' RPS programs.

**PJM-CEAC (MWh):** PJM region-wide clean energy attribute certificate (PJM-CEAC). Unbundled from energy. Eligible technologies: non-GHG-emitting resources in PJM footprint including renewables, nuclear, and hydro that may not be eligible under states' RPS. Package B: Integrated Clean Capacity Market (ICCM)

3 regionally-defined unbundled attribute products – **PJM-REC**, **PJM-CEAC**, and...

**PJM-CCC (UCAP MW)**: PJM regional clean capacity certificates (PJM-CCCs). Unbundled from capacity. 1 PJM-CCC can be awarded for the delivery of 1 UCAP MW of capacity committed and delivered into RPM, subject to PJM UCAP accreditation rules, obligations, and penalties. Sellers must be qualified to offer into the RPM in order to offer PJM-CCCs. Package C: Minimum Reliability / State Attribute Auctions

Minimum Reliability Attributes Auction: Residual auction in which PJM procures sufficient resources to satisfy locational reliability needs net of "SAPA" resources' impacts on load.

- Two stage auction process

#### **State Attributes Procurement Auction:**

PJM provides LSEs with locational marginal reliability value of clean resources

 Difference between Stage 1 MRAA revenue and Stage 2 MRAA revenue allocated to state attribute resources



Vote Results
