#### ADMINISTRATION

The Subcommittee approved the minutes of the February 4, 2014 meeting by acclamation with no objections and no abstentions.

#### 2. INC/DEC ANALYSIS

Hal Loomis of PJM provided an updated presentation of the INC/DEC analysis. He stated that the data showed no significant differences among the types of members which had credit shortfalls greater than \$50,000 from June 2012 through December 2013. After discussion of possible further analysis, PJM indicated that this topic, along with potential credit enhancements, will be on a member survey after the April 4 Credit Subcommittee meeting to determine member priorities for credit issues.

#### 3. FTR COUNTERFLOW CREDIT REQUIREMENT PROBLEM STATEMENT

Mr. Loomis presented the FTR counterflow credit requirement problem statement which was approved by the members. He stated that the issue charge would be presented at the next meeting on April 4.

#### 4. TARIFF LANGUAGE CHANGES

Mr. Loomis gave an update on the status of the tariff language changes for CTS/Export Credit and Credit Available for Virtual Transactions.

# 5. UPDATE ON JANUARY 2014 UNRESOLVED DEFAULTS AND DISCUSSION OF POTENTIAL CREDIT POLICY ENHANCEMENTS

Ms. Daugherty made a presentation on the January 2014 defaults and potential credit policy enhancements that have been suggested to minimize future defaults. For the volume bandwidth enhancement, members requested that PJM compare the January peaks with historical peaks. For the reduction in the cure period for collateral and payment



breaches from two days to one day, some members suggested two days for collateral and one day for payment. Some members suggested that members without unsecured credit to be allowed to make prepayments to reduce peaks for PMA purposes. Members were asked to send in any other enhancement suggestions.
