#### PJM Manual 34: Stakeholder Process

#### 6.3 Issue Identification and Initiation

Standing Committees are the sole Stakeholder Groups in which new issues are considered, and placed, rejected, or tabled. Task Forces shall not to take up new issues which are not already clearly in their Charge and Charter. Rather, they shall raise any potential significant new issues to their Standing Committee for consideration. Subcommittees may consider new issues related to their Charter, but shall make periodic reports to their Parent Committee including any new issues raised for consideration by the Subcommittee. In such cases, the Subcommittee Chair should consider creating a charge detailing the new issue to ensure that there is clarity on the work scope among the Subcommittee participants.

The Parent Committee retains the authority to determine the scope of work and timing for all of its subordinate groups. Once a Standing Committee, Subcommittee or Task Force accepts a new issue, that issue is now collectively owned by the membership of that group (active meeting Member participants) as part of the CBIR process. This "ownership" applies whether the issue is offered by a subordinate group or offered by a Member or group of Members. Members of the accepting committee determine future actions on that accepted issue.

- Issue charges will be drafted at the DISRS level for each issue that is within the scope of the DISRS charter.
  - DISRS consensus (verbal, no vote) will be sought for each issue charge.
  - If DISRS consensus cannot be reached for the issue charge as drafted, it will be sent to Market Implementation Committee (MIC) for approval as the DISRS parent committee.
- Once the MIC approves an issue charge, the issue can be assigned to the DISRS to be addressed.
- All issue charges being worked in the DISRS will be added to the work plan.



A stakeholder process (CBIR, CBIR Lite, etc.) as determined in the issue charge will be utilized within DISRS to develop proposed solution package(s) for each issue charge in the work plan.

- Proposed solution packages can include process, manual, and procedural changes per the DISRS charter.
- Proposed solution packages may further result in changes to the Tariff and/or Operating Agreement, which will be endorsed/approved by the senior standing committees.



Issues which may for certain reasons benefit from more expedited and/or focused treatment through the Consensus Based Issue Resolution (CBIR) steps:

- Requires Member approval of CBIR Lite process within Issue Charge
- Requires each step within the CBIR process to be addressed
- May utilize an expedited timeline to complete each CBIR step
- May utilize a subgroup of a Standing Committee to address
- Ultimate decision-making (voting) resides with Standing Committee



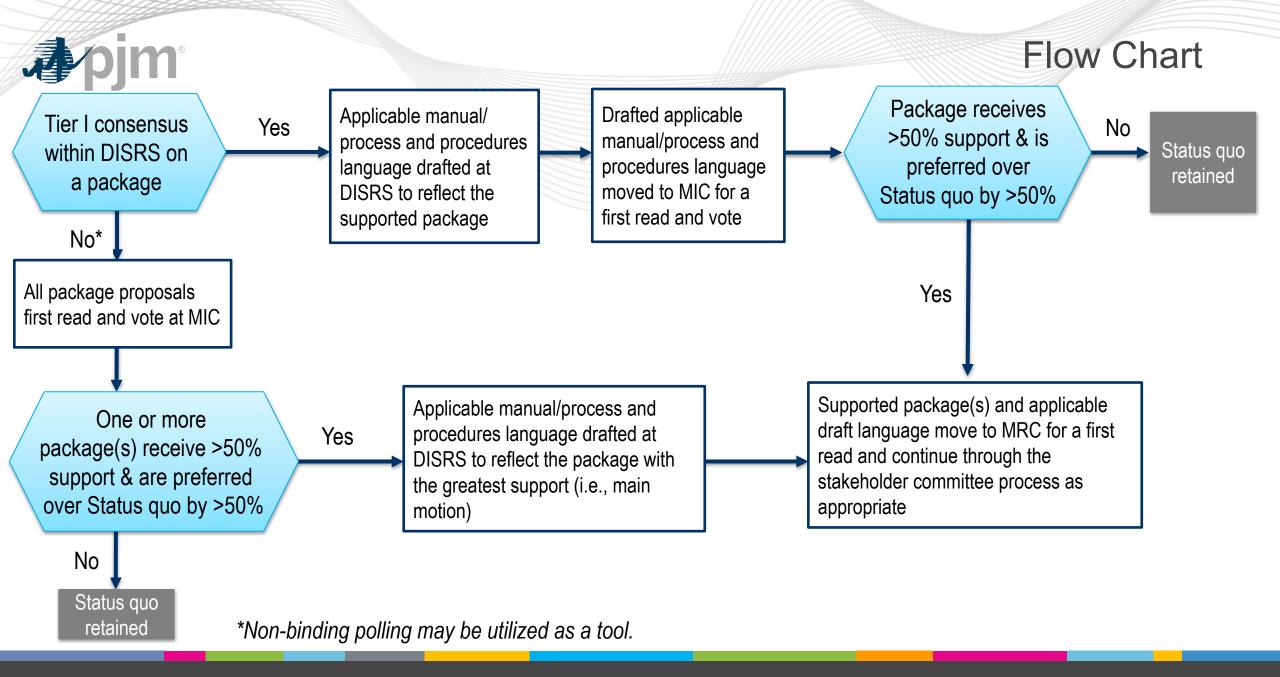
### Subcommittee Proposed Packages

#### **One Package Proposal**

- Consensus within DISRS (verbal, no vote) on one proposed package
- Manual and any other process/ procedural changes drafted within DISRS as part of package
- Manual and any other process/procedural changes will move to MIC for first read/endorsement and proceed through the stakeholder committee process as appropriate

#### More Than One Package Proposal

- Consensus not reached within
   DISRS on one proposed package
   \*Note: Non-binding polling may be utilized as a tool.
- Proposed
   packages
   proceed to the
   MIC for first read /
   endorsement
- MIC will vote on packages
   \*Note: MIC voting thresholds for simple majority and preference over status quo
- Endorsed MIC package(s) (>50% support and preferred over status quo by >50% support) along with manual, any other process/procedural changes from the main motion, and OA/Tariff revisions as appropriate, will move to MRC for first read and continue through stakeholder committee process as appropriate
