## Administration

  - Mr. Tom Hauske, PJM, reviewed an amended problem statement and issue charge to address Minimum Tank Suction Level (MTSL) costs as part of a Phase 2 discussion for the Annual Revenue Requirements for new Black Start units. The committee approved the amended problem statement and issue charge by acclamation with <u>11</u> objections and <u>1</u> abstention.

- A. Mr. Tom Hauske, PJM, continued the discussion on Annual Revenue Requirements for new Black Start units as part of Phase 1 and presented the solution packages for consideration. The committee agreed to consider this discussion a first read of packages, and will be asked to endorse a package at the April MIC meeting.
- B. Dr. Joe Bowring, Monitoring Analytics, was available for questions related to the Minimum Tank Suction Level costs as part of the Phase 2 discussion on this topic.

It was suggested by Vitol, PJM, and the IMM that a broader discussion about seams issues may be appropriate. The committee agreed to consider this discussion a first read of Package B, and will be asked to endorse this package at the April MIC meeting.
