Administration

- 1. Ms. Christina Stotesbury, PJM, and Ms. Chantal Hendrzak, PJM, provided announcements and reviewed the Antitrust, Code of Conduct, and Public Meetings/Media Participation Guidelines.
- 2. The committee approved the draft minutes from the December 14, 2016 Market Implementation Committee meeting by acclamation with <u>0</u> objections and <u>0</u> abstentions.
- 3. Ms. Christina Stotesbury reviewed the active MIC issues on Issue Tracking
- 4. Mr. Ronnie Bailey, Dominion, reviewed a temporary RAS in the Dominion Transmission Zone to account for the Yorktown generation facility retirement.

Endorsements/Approvals

5. FERC Order 825 – Shortage Pricing

Ms. Lisa Morelli, PJM, reviewed the proposed package to change the Operating Reserve Demand Curve and price shortage conditions in real time, and the associated revisions to Manual 11: Energy & Ancillary Services Market Operations. PJM will request in the compliance filing submitted on January 11, 2017, that the FERC extend the implementation date to coincide with the implementation of 5-minute settlements in February 2018, opposed to May 2017 as the Order suggests. The committee endorsed the proposed package and Manual 11 revisions by acclamation with <u>0</u> objections and <u>20</u> abstentions.

6. NCEMC Problem Statement and Issue Charge

Ms. Debbie Britt, NCEMC, reviewed a pseudo-tie meter correction problem statement and issue charge that will be worked at the Market Settlements Subcommittee. The committee approved the problem statement and issue charge by acclamation with <u>0</u> objections and <u>0</u> abstentions.

7. Manual 11 Revisions

Mr. Michael Olaleye, PJM, reviewed revisions to Manual 11: Energy & Ancillary Services Market Operations to account for the updated Regulation Requirement from the RMISTF. **The committee endorsed the Manual 11 revisions by acclamation with** <u>0</u> **objections and** <u>8</u> **abstentions.**

8. Manual 27 Revisions

Mr. Ray Fernandez, PJM, reviewed revisions to Manual 27: Open Access Transmission Tariff Accounting as part of an annual review process. The committee endorsed the Manual 27 revisions by acclamation with <u>0</u> objections and <u>0</u> abstentions.



Working Issues

9. Annual Revenue Requirements for new Black Start Units

Mr. Tom Hauske, PJM, continued the discussion on Annual Revenue Requirements for new Black Start units and presented a solution option for consideration. Additional options and packages may be sent to the MIC Chair or Secretary in advance of the February MIC meeting. *Issue tracking: Annual Revenue Requirements for new Black Start Units*

10. Spot-in Transmission Service for Energy Imports from NYISO

Mr. Chris Pacella, PJM, provided an update on the Spot-in Transmission Service Special Session meeting held on December 21, and reviewed next steps. A revised problem statement and issue charge was presented for the consideration of additional energy import solutions on all seams. Mr. David Hastings, Market Interconnection, LLC, motioned to approve and Mr. Bob O'Connell, Main Line Electricity Market Consultants, seconded the motion to vote on the amended problem statement and issue charge. **The amended problem statement and issue charge were approved by acclamation with** <u>0</u> **objections and** <u>0</u> **abstentions**. *Issue Tracking: Spot-in Transmission Service for Energy Imports from NYISO*

11. FERC NOPR Updates

- A. Ms. Lisa Morelli, PJM, provided an update the Notice of Proposed Rulemaking related to pricing Fast Start Resources, as part of the price formation proceeding.
- B. Mr. Andrew Levitt, PJM, provided an update on the Notice of Proposed Rulemaking related to Electric Storage Participation in Markets Operated by Regional Transmission Organizations and Independent System Operators.

12. Seasonal Capacity Deficiency Letter

Ms. Jennifer Tribulski, PJM, provided an update on the seasonal capacity deficiency notice response.

13. Motions to Lodge and for Commencement of Compliance Process of the IMM for PJM

Dr. Joe Bowring, Monitoring Analytics, presented historical replacement capacity examples and provided comment on the <u>Motions to Lodge</u> and for Commencement of Compliance Process submitted on behalf of Monitoring Analytics on December 30, 2016. Ms. Jen Tribulski, PJM, provided PJM's perspective on the motions as well.

14. 2017/2018 ARR/FTR Process

Mr. Brian Chmielewski, PJM, provided an update on the PJM <u>compliance filing</u> submitted to the FERC on November 14, 2016 impacting the annual ARR/FTR process, and provided details on the timeline and communication plan to introduce the corresponding ARR/FTR changes.

15. Synchronized Reserve Events in Emergency Procedures Application

Mr. David Hislop, PJM, provided an update on the effort to add Synchronized Reserve events back into the Emergency Procedures application.



16. NYIS Interface Definition

Mr. Tim Horger, PJM, provided an update on the NYIS Interface Definition to support the post ConEd Wheel implementation, and was available to answer questions on the Inter-Regional Coordination efforts.

Future Agenda Requests

Mr. Dave Pratzon, GT Power Group, requested a future agenda item at the MIC or MC Webinar for PJM to present more details, such as pricing, the clearing mechanism, and model used, for the 10,000 MW from the 3rd Incremental Transition Auction.
