| Daily Unforced Capacity Obligation | Modifying RAA to include full definition, rather than a cross-reference. | OATT Attachment DD, section 2.18, RAA section 1.11 |
| Delivery Year | Modifying RAA to cross reference section 5 of DD. Modifying OA to add FRR capacity plan to mirror RAA. | OATT Attachment DD, section 2.19, RAA section 1.12 |
| Demand Resource Factor | Modifying "DR Factor" definition to match "Demand Resource Factor" definition in OA and RAA. | OATT Attachment DD, section 2.21, RAA section 1.15 |
| Electric Distributor | Revising OA definition to match more correct and inclusive RAA definition. | RAA, section 1.18 |

| Operating Agreement of the PJM Interconnection, L.L.C. / Operating Agreement | Revising OA and RAA to match Tariff, and capitalizing "Members". | RAA, section 1.57 |
| State | Revising definition in Tariff to match OA. | Tariff, section 1.42D, Tariff Attachment GG |
| Zonal Capacity Price | Matching RAA to more correct and inclusive definition in OA. | RAA, section 1.88 |
