Dear Ms. Foley:

On October 26, 2011, PJM Interconnection, L.L.C. (PJM) submitted an executed Wholesale Market Participation Agreement (WMPA)¹ entered into among PJM, EffiSolar Energy Corporation (EffiSolar) and Jersey Central Power & Light Company, a FirstEnergy Company (JCP&L). PJM states that it is submitting this WMPA for filing because EffiSolar intends to engage in wholesale sales in the PJM markets from a generating facility connected to the JCP&L distribution facilities.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. §375.307, your submittal is accepted for filing, effective September 29, 2011, as requested.

The filing was noticed on October 27, 2011, with comments, interventions and protests due on or before November 16, 2011. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2011)), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.
