Dear Ms. Foley:

On September 22, 2011, you filed, on behalf of PJM Interconnection, L.L.C. (PJM), a non-conforming interconnection service agreement (ISA)¹ among PJM, Exelon Generation Company (Exelon) and Commonwealth Edison Company (ComEd). You state that the interconnection agreement is being submitted because it contains non-standard terms and conditions unique to the existing nuclear generating station.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, your submittal filed in the above referenced docket is accepted for filing, effective August 30, 2011 as requested.

Notice of the filing was published on September 30, 2011, with comments, protests, or interventions due on or before October 20, 2011. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2011)), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.
