Dear Ms. Tribulski:

On November 30, 2011, PJM Interconnection, L.L.C. (PJM) submitted an executed Wholesale Market Participation Agreement (WMPA)¹ entered into among PJM, RE Cranbury Solar I, LLC (RE Cranbury), and Public Service Electric & Gas Company (PSE&G). PJM states that it is submitting this WMPA for filing because the RE Cranbury intends to engage in wholesale sales in the PJM markets from a generating facility connected to the PSE&G distribution facilities.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. §375.307, your submittal is accepted for filing, effective November 1, 2011, as requested.

The filing was noticed on November 30, 2011, with comments, interventions and protests due on or before December 21, 2011. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2011)), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.
