- Original Poll: To gather stakeholder perspectives regarding potential design considerations for developing a solution to address the Minimum Offer Price Rule and its future application in the capacity market in order to inform PJM prior to PJM developing its Critical Issue Fast Path Stage 1 proposal.
- Opt-In Poll: In response to the requests made at the April 20, 2021 CIFP MOPR meeting for a voluntary attribution of posted comments submitted for the CIFP MOPR poll that was issued on April 9, 2021 and closed on April 16, 2021, we issued a second poll to allow stakeholders to opt in to having their poll comments posted with company attribution.
