

## OC Special Call-TO Data Feed Issue Final Proposal Report

August 18, 2014

### **Issue Summary**

#### Problem Statement/Issue Charge

Initial Problem Statement and issue Charge were brought forward by AEP. PECO proposed a subsequent scope change.

Initial and revised Problem Statement/Issue Charge endorsed by Markets and Reliability Committee on March 14, 2014 and June 26, 2014 respectively.

Number of meetings covering this topic: 6

### Summary of Work

The group followed the expedited / focused application of the Consensus Based Issue Resolution (CBIR) process – referred to as CBIR Lite to manage its efforts. Through education, discussion and debate, PJM staff and stakeholders reached Tier 1 consensus on a single proposal to address the issue.

#### **Recommended Proposal**

The proposal focused on streamlining the administration work involved in the process without minimizing the level of protection of the data shared between the generation owner and the transmission owner. The proposal requires both Operating Agreement and PJM Manual changes.

The changes being recommended include:

- Eliminate the requirement for a separate Data Confidentiality Agreement; instead, revise Operating Agreement to include terms and conditions of a universal non-disclosure agreement.
- Remove the detailed decision points / criteria used for evaluating whether or not the data can be provided
  to the transmission owner; instead, require that the transmission owner provide an engineering-based
  reason of why the data is required.
