1. Dave Souder, PJM, called the meeting to order. Molly Mooney, PJM, reviewed the Antitrust, Code of Conduct, media participation, and WebEx guidelines.
2. Molly Mooney reviewed the March 9, 2021 Planning Committee Agenda. No changes to the agenda were requested. 4. CIR Problem Statement/Issue Charge

5. Interconnection Process Reform  
Jason Connell, PJM, provided a first read of a problem statement and issue charge to address Interconnection Process Reform which was the result of a number of Interconnection Process Workshops. The committee will be asked to approve the issue charge at the April PC meeting.
6. New Service Requests Deficiency Review Requirements  
Jason Connell, provided a first read of a problem statement, issue charge and proposed solution to address new service requests deficiency review requirements. Draft versions of associated Tariff language were posted with meeting materials for informational purposes. Stakeholders provided feedback on the proposed solution. The committee will be asked to approve the issue charge and endorse the proposed solution as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at the April PC meeting.

## 7. Interconnection Construction Service Agreement Superseding Language and Automatic Termination Provision

Mark Sims, PJM, provided a first read of a problem statement, issue charge and proposed solution to address concerns associated with the pro forma Interconnection Construction Service Agreement's (a) lack of superseding language and (b) current automatic termination provision. Draft versions of associated Tariff language were posted with meeting materials for informational purposes. Alex Stern, PSEG, offered a friendly amendment asking PJM to send notice back to the TOs upon cancellation of ICASAs. PJM will take the friendly amendment into consideration. The committee will be asked to approve the issue charge and endorse the proposed solution as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at the April PC meeting.
