 - Seeking to change governing documents and manuals to facilitate
 Transmission Owner access to generator real time data and outage information needed for TO real time analyses

5/27/14

- Group discussion initiated under OC
 - CBIR "Lite" process

8/25/14

- Final Report reviewed
 - Six total meetings
 - Tier 1 consensus on a single proposal



Objectives:

- Streamline the administration of the approval process
- Maintain the level of protection of data shared between GO and the TO
 - Replace current confidentiality agreement process with confidentiality provisions to be included in Operating Agreement
 - Simplify criteria for providing data to TO
 - Real-time generator data internal to TO zone
 - Justification not required
 - Real-time generator data external to TO zone must confirm that generator:
 - is in current TO EMS model, or,
 - will be in TO EMS model due to expansion of model by TO



Operating Agreement revisions

The changes in section 18.17 (Confidentiality), which include:

- New section 18.17.7: Disclosure of Generator Data to Transmission Owners Includes terms and conditions of a universal non-disclosure agreement
- 2. Minor changes in section 18.17.6 to prevent conflict with language in new section 18.17.7.
