## Types of applications:

- Attachment N – new generation and updates to existing generation
- Attachment S – merchant transmission requests
- Attachment Y – new generation, less than 2 MW and not seeking Capacity Interconnection Rights (CIRs)
- Attachment BB – inverter based generation no larger than 10kW
- Attachment EE – ARR request
- Attachment FF – Long term firm request

- Some updates put in place over the past 5 years
- Updating and improvements to application processes needed
- New processes are targeted to:
  - Improve user experience
  - Decrease questions about information required in process
  - Improve data routing inside of PJM
  - Improve data validation during submission
