

# **Meeting Minutes**



Resource Adequacy Analysis Subcommittee Conference Call/WebEx May 31, 2018 3:00 p.m. – 4:00 p.m. EST

#### Administration

Mr. Falin opened the meeting and reviewed the agenda. Mr. Quevada performed roll call. The meeting minutes from the April 27, 2018 meeting were approved and will be posted as final.

#### Manual 20 Revisions

Mr. Rocha-Garrido presented new methodology to calculate IRM capacity model for the winter peak week. The subcommittee endorsed the manual revisions.

## 2018 RRS Assumptions

Mr. Quevada reviewed the draft assumptions for the 2018 Reserve Requirement Study and sought comments from the subcommittee. The subcommittee endorsed the RRS Assumptions.

#### 2018 RRS Load Model Assessment

Mr. Rocha-Garrido reviewed detailed results of analysis performed by PJM staff regarding the selection of a load model time period for both PJM and the World regions. The analysis focused on the 2022/2023 Delivery Year and followed the procedure approved by the Planning Committee at its July, 2009 meeting.

PJM recommended a 10 year load model based on the years 2003-2012 for use in the 2018 RRS Base Case. PJM also recommended that the World peak be switched to a different July week so that PJM and World peak on the same month but not on the same week. The same approach was also used in the 2016 and 2017 RRS.

The subcommittee will be asked to endorse the load model time period at its July meeting.
