# Essential Actions to Industry Cold Weather Preparations for Extreme Weather Events - Link

- Issued May 15, 2023
- Requires GO to provide cold weather data to its RC, BA, and TOP
  - Refer to Essential Actions #7 and #8 in NERC Alert
  - PJM is the NERC Registered RC and BA for its footprint; and TOP for its footprint, except for facilities at or below 138kV that are owned and operated by American Electric Power (AEP), and the U.S. Department of Energy facility at Portsmouth (OH)
- Reporting for NERC Registered Entities required by midnight Eastern on October 6, 2023



- PJM collecting information through an eDART Data Request
  - Issued to all eDART units only NERC Registered Entities must complete
  - GOs will be required to upload the responses provided to NERC
  - GOs will also be required to answer some PJM-specific questions
  - Data Request will be open from August 1 though October 16

#### **ACTION REQUIRED**

As communicated at the July 13, 2023 Operating Committee, PJM is issuing a new data request to all generation resources via eDART. The primary purpose of this data request is to allow NERC-registered generation resources to provide PJM, as Balancing Authority (BA), Reliability Coordinator (RC), and Transmission Operator (TOP), with information mandated by a NERC level 3 Alert issued on May 15, 2023.

The data request is being issued to all generation resources to allow PJM to validate NERC registration information contained in PJM's Resource Tracker portal. Generating resources that are not NERC-registered simply need to answer one question, indicating that they are not NERC-registered, all others must complete the entire data request. The data request will be open from Tuesday, August 1 through Monday, October 16.
