MSRS Usage Guidelines

MSRS provides PJM participants timely access to comprehensive settlements information. The system allows users to access and download settlements reports in a variety of formats and to view the reports online. Due to the number of available reports and users accessing them, PJM requests users that query the MSRS system using browserless functionality adhere to the following suggestions to prevent overuse and help maintain overall system performance:

1) Specify Report Intervals Correctly

Each MSRS Report has a defined Query Interval published in the MSRS Report Dictionary posted on PJM.com. Special attention should be made to avoid querying each individual day for monthly and/or weekly reports because doing so would result in the same report being generated repeatedly.

There are 5 possible intervals:

2) Identifying Reports Available for Download

To assist users in identifying reports that are newly available or recently updated, there are two existing MSRS reports:

- a) Published Report Versions This report displays any report version that was published between user specified dates. This report can help users identify all newly available or updated reports during the specified time period.
- b) Report Version Availability This report will display every version that exists for each report with data that overlaps with the user-specified date range. It will display the report name, version, and date the version was published.

Note that these reports are not company specific. There can be cases when a new version is published but company-specific data was not updated.

3) Concurrent Report Downloads

Due to the number of MSRS users, it is requested users download no more than 4 reports at the same time.
