

Members Committee One Hundred Eighty-first Meeting PJM Conference and Training Center, Audubon, PA September 27, 2018 1:15 p.m. – 5:00 p.m. EPT

Administration

- A. Mr. Anders announced the following new member companies approved for PJM membership since the last meeting, bringing the total membership to 1052:

 - Prime Trading, LLC (Voting Member) selected the Other Supplier sector
 - QPH CAPITAL, LLC (Voting Member) selected the Other Suppler sector
 - R2M Technologies Inc. (Voting Member) selected the Other Supplier sector
 - Renewable Energy Aggregators Inc. (Voting Member) selected the Generation Owner sector

Mr. Anders noted that three members had withdrawn and four more members in default have had their membership rights terminated since the last meeting.

- B. Mr. Anders confirmed the presence of a quorum.
- C. Mr. Anders reminded participants of Antitrust and Code of Conduct requirements.

Items A and B were **approved** by acclamation with no objections or abstentions.

- B. Proposed Open Access Transmission Tariff (OATT) and the Reliability Assurance Agreement (RAA) revisions associated with the registration process for aggregated seasonal Demand Response resources

Endorsements/Approvals

- 1. Financial Transmission Right (FTR) Liquidation Process
 - A. Ms. Suzanne Daugherty reviewed proposed Operating Agreement (OA) and Tariff revisions associated with FTR default liquidation. Following discussion, Proposal B was <u>approved/endorsed</u> in a sector-weighted vote with 4.01 in favor.
 - B. This item was withdrawn.



2. Market Efficiency Process Enhancement Proposal

Mr. Nicolae Dumitriu Market Efficiency reviewed the phase 1 proposal developed at the Market Efficiency Process Enhancement Task Force (MEPETF) including associated OA revisions. Following discussion, the proposed OA revisions were **approved** in a sector-weighted vote with 4.41 in favor.

3. Opportunity Cost Calculator

Mr. Stu Bresler and Dr. Joe Bowring discussed the recent events related to the PJM and Independent Market Monitor's (IMM) Opportunity Cost Calculators (OCC), and an agreement reached between PJM and the IMM regarding a plan to facilitate PJM approving results of the IMM's OCC on an expedited basis. Mr. Bob O'Connell, Panda, moved and Mr. John Rohrbach, ACES on behalf of SMECO, seconded deferring vote on the proposed OA revisions. The Members present <u>approved</u> the motion by acclamation with no objections or abstentions.

4. Variable Operations and Maintenance (VOM)

Mr. Greg Poulos, CAPS, and Ms. Ruth Ann Price, DE Office of the Peoples' Counsel, objected to voting on the issue on this same day that the Markets & Reliability Committee voted on it. Following discussion, the Members present **approved** voting the issue at this meeting in a sector-weighted vote 3.10 with in favor (note that the threshold for approval of this vote was simple majority or 2.50). Following discussion, the proposal was **failed** in a sector – weighted vote with 2.92.

5. Quadrennial Review

Mr. Carl Johnson, PJM Public Power Coalition, moved and Mr. Bob O'Connell seconded that the voting results of the September 27, 2018 MRC be accepted and that the detailed voting reports be provided to the PJM Board of Managers. Following discussion, the PJM proposal was **approved** by acclamation with one objection and no abstentions.

6. Liaison Committee (LC) Charter

Mr. Greg Poulos, CAPS on behalf of DC Office of the Peoples' Counsel, moved and Ms. Ruth Ann Price, DE Division of the Public Advocate, seconded a motion to grant exception to the LC charter addressing attendance at the October 3, 2018 LC meeting with the Board of Managers. Mr. Bob O'Connell moved and Mr. Barry Trayers, Citigroup Energy, Inc. seconded to suspend the rules and not publically produce a detailed voting report of the results of Mr. Poulos' motion. The motion to suspend the rules and not publically produce detailed voting reports was <u>approved</u> in a sector-weighted vote with 3.42 in favor. Following discussion, the motion to grant exception <u>failed</u> in a sector-weighted vote with 2.43 in favor.

Mr. Mike Borgatti provided a first reading of a proposed problem statement and issue charge related to potential enhancements to the stakeholder process developed in response to feedback gathered in the Stakeholder Process Super Forum held on July 25, 2018.
