#### Administration

Mr. Stu Bresler and Mr. Dave Anders welcomed stakeholders and provided the Anti-trust and Code of Conduct announcements. Mr. Bresler noted the retirement of Mr. Fran Barrett and Mr. Stan Williams and thanked them for their many contributions to PJM and stakeholders.

#### **Consent Agenda**

Ms. Amber Thomas, PPL, requested that Item A be removed from the Consent Agenda for separate consideration. Ms. Thomas proposed a friendly amendment to the minutes of the December 5, 2019 meeting to reflect discussion at that meeting regarding the accuracy of AMP presentation materials associated with the then proposed Problem Statement and Issue Charge addressing transmission asset end of life processes, as well statements made by PJM. Mr. Erik Heinle, DC Office of the Peoples' Counsel, objected to the proposed amendment, and therefore it was not incorporated in the minutes. Following discussion, Item A, the minutes of the December 5, 2019 meeting, were <a href="mapproved">approved</a> as posted in a sector-weighted vote with 3.96 in favor. Mr. Bresler indicated that PJM will add a Disclaimer on PJM.com reflecting that posting on PJM.com of documents generated by stakeholders does not imply endorsement by PJM.

Mr. Ray Fernandez noted that the Manual 27 revisions in Item E were updated to remove "or Non-Firm" from section 6.2.4. Items B through E were **endorsed** by acclamation with no objections and one abstention (Item E).

### **Endorsements/Approvals**

#### 1. FTR Product Range and Auction Process

Mr. Tim Horger reviewed proposed revisions to the Operating Agreement and Manual 6: Financial Transmission Rights related to the Financial Risk Mitigation Senior Task Force (FRMSTF) endorsed solution package for FTR Product Range and Auction Process. Following discussion, the proposed revisions were **endorsed** by acclamation with seven objections and no abstentions.

### 2. Competitive Transmission Proposal Fee

Mr. Mark Sims reviewed revisions to the Operating Agreement to implement changes to the competitive transmission proposal fee structure. Following discussion, the proposed revisions were **endorsed** by acclamation with one objection and no abstentions.

#### 3. Comparative Cost Framework

Mr. Mark Sims reviewed the Comparative Cost Framework proposed revisions to PJM Manual 14F: Competitive Planning Process related to the cost commitment process. Mr. Alex Stern, PSEG, presented procedural options on behalf of the PJM Transmission Owners. Following discussion, the proposed revisions were **endorsed** in a sector-weighted vote with 3.92 in favor. Issue Tracking: Consideration of Cost Containment

#### 4. Real-Time Values Problem Statement and Issue Charge

Ms. Susan Kenney reviewed a proposed Problem Statement and Issue Charge addressing a review of Real Time Values Market Rules. Following discussion, the proposed Issue Charge was <u>approved</u> by acclamation with no objections or abstentions.

#### 5. Governing Document Revisions for Parameter Limited Schedules

Mr. Adam Keech reviewed proposed Tariff and Operating Agreement revisions regarding the use of market-based Parameter Limited Schedules. Following discussion, the proposed revisions were **endorsed** in a sector-weighted vote with 4.67 in favor.

#### 6. Modeling Generation Senior Task Force (MGSTF)

Mr. Stan Williams provided an overview of the Modeling Generation Senior Task Force recommended long-term implementation plan with near-term implementation proposals. Following discussion, the MGSTF's recommendations regarding hourly differentiated ramp rates and additional segments were **endorsed** by acclamation with no objections or abstentions. Mr. Bob O'Connell, PPGI Funds, moved and Mr. Gary Greiner, PSEG, seconded deferring vote on the MGSTF's recommendation regarding soak time to the January 2020 MRC meeting. The motion to defer was **approved** by acclamation with no objections or abstentions.





### 7. Fuel Security Senior Task Force (FSSTF)

Mr. Tim Horger discussed the activities of the Fuel Security Senior Task Force and the proposed recommended path forward. Mr. O'Connell moved and Mr. Ken Foladare, Geenix Solar, seconded that PJM continue to monitor parameters considered in the fuel security analysis and revisit with stakeholders as necessary. Ms. Susan Bruce, PJM Industrial Customer Coalition, offered a friendly amendment to require reporting to the MRC not less frequently than every 18 months. Mr. O'Connell and Mr. Foladare accepted the friendly amendment and therefore it was incorporated into the motion. Following discussion, the motion was **approved** in a sector-weighted vote with 4.50 in favor. Mr. Heinle moved and Mr. O'Connell seconded sunsetting the FSSTF. The motion was **approved** by acclamation with three objections and no abstentions.

Ms. Nigeria Bloczynski provided an overview of the proposals developed by the Financial Risk Mitigation Sr. Task Force related to best practices in financial risk management, along with associated Tariff and Operating Agreement revisions. The committee will be asked to endorse the revisions at its next meeting. Members Committee endorsement will be sought on the same day.

#### 9. PJM Manuals

A. Mr. Robert Dropkin reviewed proposed revisions to PJM Manual 38: Operations Planning including updates from the periodic cover-to-cover review and updated procedures. The committee will be asked to endorse the revisions at its next meeting.
