# **Sector Challenge Process Enhancements**

December 15, 2021



### **Background and Proposal**

**Problem Statement:** Currently, questionable sector selections may only be challenged one time per year. Challenges to the sector selection of an existing Member must be made within 30 days of the Annual Meeting. Challenges to a new Member's sector selection must be made within 30 days of the new Member joining PJM.

Over the last three years, PJM has required changes to the sector selections of 14 members. PJM has determined that a sector modification was warranted for 88% of Sector Challenges.

To ensure the integrity of sector-weighted voting, Members explored reforms to allow for more timely inquiries, if needed, at the PJM Stakeholder Process Forum (SPF) over the last 18 months.

**Proposed Solution:** Reform the Sector Challenge provisions of Operating Agreement, Section 8.1.3, to permit more timely examination of potentially improper sector selections, as well as development of Member protections against spurious or multiple challenges. Such reforms will supplement PJM's new process to evaluate sector changes on an ongoing basis that was announced at the November SPF.



#### 8.1.3 Sector Challenge.

(a)Any Member ("Challenging Member') may request that PJM review the qualification of another Member ("Challenged Member") in the Challenging Member's sector to participate in that sector <u>if the</u> <u>basis for such Challenged Member's qualifications have not been subject to a Sector Challenge review</u> in the prior 24 months, <u>unless there is a material change in the Challenged Member's business interests</u> <u>with PJM</u>. Any five Members may request that PJM review the qualification of another Member to participate in the sector in which that Member is presently assigned.

(b)A request pursuant to section 8.1.3(a) above, ("Challenge") shall be submitted in writing and shall describe the basis for the Challenge, which shall include, but not limited to, the reasons why the Challenged Member may not have any Active and Significant Business Interests in its present sector. Except for new Members, a Challenge must be submitted within 30 days after the Annual Meeting of the Members. For new Members, a Challenge must be submitted within 30 days after the Annual Meeting in which they are introduced.

#### Background:

#### Original Driver / Issue to Address:

- In the spring of 2020, several members requested that PJM take a more active role in evaluating and overseeing the sector selection and challenge process. This was brought up for discussion due to several issues that arose during the annual recertification process in 2020 (i.e. companies selecting sectors that they were not qualified for, related parties trying to join inaccurate sectors, etc.).
- In the Fall of 2020, PJM provided an overview to the SPF on the enhancements that they've made to the process to confirm and validate selections of new members and members who change sectors in the annual process. The only remaining issue for the SPF to discuss is whether further changes could be made to the challenge process to enhance administrative efficiency for PJM and ensure accurate member selections on an ongoing basis.
