 - Skyler Marzewski, PJM, reviewed conforming changes to Manual 11: Energy & Ancillary Services Market Operations, Manual 18: PJM Capacity Market, and Manual 28: Operating Agreement Accounting as part of CIFP-RA: Phase 2.
 - The committee endorsed the Manual 11 revisions at this meeting by acclamation with 0 objections and 4 abstentions.
 - The committee endorsed the Manual 18 revisions at this meeting by acclamation with 0 objections and 0 abstentions.
 - The committee endorsed the Manual 28 revisions at this meeting by acclamation with 0 objections and 0 abstentions.
- 2. Demand Response Availability Window (9:20 10:30)
 - Pat Bruno, PJM, presented a First Read of two PJM solution packages for Demand Response Availability Window, one for Delivery Year 26/27 and one for Delivery Year 27/28.
 - Joe Bowring, Monitoring Analytics, presented a First Read on a proposed IMM solution for Demand Response Availability Window.

 Issue Tracking: DR Availability Window

The committee endorsed the following packages at this meeting:

- PJM Package for DR Availability Window for DY 26/27 with 150 (54.3%) in favor, 126 (45.7%) opposed, and 3 abstentions. A second vote showed stakeholders preferred the PJM Package for DY 26/27 over the status quo with 127 (50.4%) in favor, 125 (49.6%) opposed, and 25 abstentions.
- PJM Package for DR Availability Window for DY 27/28 with 197 (77%) in favor, 59 (23%) opposed, and 23 abstentions. A second vote showed stakeholders preferred the PJM Package for DY 27/28 over the status quo with 197 (77%) in favor, 59 (23%) opposed, and 23 abstentions.





The committee did not endorse the following packages at this meeting:

IMM Package for DR Availability Window with 109 (40.1%) in favor, 163 (59.9%) opposed, and 7 abstentions. A second vote showed stakeholders did not prefer the IMM Package over the status guo with 109 (40.1%) in favor, 163 (59.9%) opposed, and 7 abstentions.

The PJM Package for DR Availability Window for DY 27/28 will move to the Markets & Reliability Committee as the Main Motion.

The PJM Package for DR Availability Window for DY 26/27 will move to the Markets & Reliability Committee as the Alternate Motion.
