Michele Greening reviewed proposed revisions to Manual 34: PJM Stakeholder Process addressing a pathway for stakeholder issues FERC rejected. Lynn Horning, American Municipal Power, moved and Ruth Price, Delaware Division of the Public Advocate, seconded the proposed revisions. Following discussion, the committee **approved** the proposed revisions by acclamation with no objections or abstentions.

2. Deactivation Enhancements Senior Task Force (DESTF)

Chantal Hendrzak provided an update regarding the activities of the Deactivation Enhancements Senior Task Force (DESTF) and will review the proposed solution

package endorsed by the DESTF and corresponding Tariff revisions. Same day endorsement was achieved at the January 23, 2025 Markets and Reliability Committee (MRC). Following discussion, the committee **endorsed** the proposed Tariff revisions in a sector-weighted vote with 4.714 in favor.
