1. Capacity Market Enhancements – ELCC Accreditation Methodology

Target Completion Date

2025 Q2

Issue Status

The MRC approved the ELCC Accreditation Methodology Issue Charge at the 10/30/2024 meeting and initiated a new stakeholder group to work the issue, the Effective Load Carrying Capability Senior Task Force (ELCCSTF).

The ELCCSTF started the CBIR process at the 12/5/2024 meeting, including a review of the Problem Statement, Issue Charge, and draft work plan for the issue.

At the ELCCSTF meetings on 1/24/2025, 2/3/2025, and 2/4/2025, design components and solutions options for this issue were discussed by stakeholders. Following the 2/4/2025 meeting, the senior task force took an offline vote on packages related to two design components related to 1) ELCC Classes utilized in the ELCC Accreditation Methodology and 2) measures to provide greater certainty in ELCC Accreditation between the BRA and final ELCC values determined for a delivery year.

The ELCCSTF endorsed solution packages for both sets of reforms. The [voting results](#) and the post meeting matrix been posted under the February 4, 2025 meeting materials on the [ELCCSTF page](#).

The solutions for both sets of reforms were first read at the February 20 MRC, with Package B (ODEC and PJM) as the Main Motion and Package C (PJM) as the Alternative Motion. Same day MRC and MC endorsement of both sets of reforms will be sought at the March 19 meetings.

The ELCCSTF is continuing work on the remaining design components and solution options. The updated [work plan](#) calls for the ELCCSTF's work to be completed on remaining design components and solutions by June 2025.

Action Requested

Stakeholders are asked to continue to provide input on solution options and packages on the remaining design components in ELCC Accreditation Methodology matrix. Discussion on solution options is expected to continue at the March 18 and subsequent ELCCSTF meetings.



2. Capacity Market Enhancements – Data Transparency

Target Completion Date

Issue Status

The MRC approved the Issue Charge at the 10/30/2024 meeting and initiated a new stakeholder group to work the issue, the Effective Load Carrying Capability Senior Task Force (ELCCSTF).

At the 12/5/2024 ELCCSTF meeting, the Problem Statement, Issue Charge, and draft work plan for the issue were reviewed. At the ELCCSTF meetings on 12/20/2024 and 1/10/2025, the CBIR process continued with discussion of interests, design components and solutions options.

The senior task force continued discussion on solution options and packages at its meetings on 2/19/2025 and 3/6/2025. At the 3/6/2025 meeting, packages were presented by PJM and Dominion. Final solution packages will be reviewed at the 3/18/2025 meeting followed by an offline vote. The vote and corresponding instructions will be sent via the ELCCSTF email list.

Action Requested

Stakeholders are asked to provide any additional solution options and packages to the facilitation team ahead of the 3/18/2025 meeting. Members are also asked to make sure they are established in the ELCCSTF email list, ELCCSTF roster and voting application if they intend to participate in the vote. Instructions were posted under the meeting materials for the 3/6/2025 ELCCSTF.

3. Capacity Market Enhancements – CETL

Target Completion Date

June 2025

Issue Status

The Planning Committee (PC) approved the Capacity Markets Enhancement - Capacity Emergency Transfer Limit (CETL) Issue Charge at the 11/6/2024 meeting and held a special session to provide education on CETL on 12/16/2024. The MRC voted to approve the re-assignment of the Issue Charge to the ELCCSTF at its 12/18/2024 meeting.

At the 1/10/2025 ELCCSTF, the draft work plan for addressing the CETL issue was reviewed. The senior task force agreed to defer work on this issue to allow time to focus on solution packages on the Accreditation Methodology issue to meet the targeted filing timeline for the issue. The senior task force is anticipated to begin discussions on the CBIR issue at its 3/18/2025 meeting.
