The Liaison Committee
Charter provides explicit
meeting attendance
requirements to be
enforced for each LC
meeting:

- Attendance both in person and on the phone is limited to the PJM Board, the LC membership (which comprises chosen PJM member representatives from each sector), PJM members, the LC secretary and PJM audiovisual staff.
- Nonmembers, including PJM staff, the Independent Market Monitor, state commission representatives and Federal Energy Regulatory Commission representatives are not permitted to attend.

Registration resides behind a secured workplace requiring additional credentials and access.



## Standing Attendee (Regular Attendance):

- Access approval will be sought from an existing Members Committee roster member.
- Once granted, the individual will be able to register for future LC meetings.

# Designated Attendee (Specific Meeting Attendance):

- Validation will be sought from an existing Members Committee roster member.
- Once validated, the individual will be provided meeting credentials for the specific meeting designated.



### LC Registration Requirements

#### **Mandatory Registration**



Attendees must register in advance of the meeting.



Meeting registration will be closed at 5 p.m. EPT on Thursday, July 24, 2025, and late registrations will not be permitted.



Anyone who seeks to attend but who has not registered by 5 p.m. EPT on July 24 will **not** be permitted to attend.



Registered attendees must refrain from forwarding the Webex credentials to others who have not registered in advance.
