Administration

1. Lisa Drauschak and David Anders welcomed stakeholders and provided the Anti-trust, Code of Conduct, and Meeting Participation announcements. Lisa Drauschak noted the addition to the agenda of Item X: Cost Allocation Issues Related to DOE 202(c) Orders. There was no objection to this agenda addition.

Consent Agenda

Items A through C were **approved/endorsed** by acclamation with no objections and one abstention:

- A. Draft minutes of the May 21, 2025 meeting of the Markets and Reliability Committee (MRC).
- B. Proposed revisions to Manual 12: Balancing Operations resulting from its periodic review and conforming to the FERC Order (Docket # ER25-1095) addressing market rules around hybrid resources.

Endorsements

2. Manual 14H: New Service Requests Cycle Process Revisions

Chris Holt discussed the June 10, 2025 FERC Order in Docket No. ER25-1544-000, noting that the content of the Order supersedes the formerly reviewed proposed Manual 14H: New Service Requests Cycle Process. He noted that proposed conforming revisions to Manual 14H addressing the cycle process and site control modifications will be previewed at the July Planning Committee meeting. The committee will be asked to endorse the conforming Manual revisions on first read at its next meeting.

3. Storage Integration (Phase II): Transmission Asset Utilization in Operations

Dave Anders discussed a proposed Problem Statement and Issue Charge addressing operations utilization of storage as a transmission asset, noting that two alternative Issue Charges had been posted as proposed by Constellation and Exelon. Following discussion, to allow the potential for consensus on a single proposed issue charge, the committee resolved to defer voting on a proposed issue charge until its next meeting.

X. Cost Allocation Issues Related to DOE 202(c) Orders

Jennifer Tribulski presented a proposed Problem Statement and Issue Charge related to Cost Allocation Issues Related to DOE 202(c) Orders. Carl Johnson, PJM Public Power Coalition, proposed an amendment to delete Out of Scope Item C, and to insert “existing” in Out of Scope Item D before “Governing document rate”. Jennifer Tribulski accepted this proposed amendment. Following discussion, the Issue Charge as amended was **approved** by acclamation with no objections and three abstentions.

First Readings

4. Sub-Annual Capacity Market Issue Charge

Jacob Finkel, Commonwealth of Pennsylvania, reviewed a proposed Problem Statement and Issue Charge to address a sub-annual capacity market. The committee will be asked to approve the proposed issue charge at its next meeting.

5. Dual Fuel Capacity Definitions (9:55-10:20)

James Davis, Dominion, presented a proposed Problem Statement, Issue Charge and proposed solution addressing modifications to the Dual Fuel Capacity Definitions contained in the Reliability Assurance Agreement to expand the definition of dual fuel resources to encompass dedicated fuel sources that are not strictly “onsite.” Carl Johnson proposed an amendment to add the word “solely” to clause (2) of both the Gas Combined Cycle and Gas Combustion Turbine Dual Fuel Classes as follows: “... (2) can be directly transported *solely* to the resource from an alternate delivery system dedicated to the resource ...”. The committee will be asked to approve the Issue Charge and endorse the proposed solution and corresponding Reliability Assurance Agreement as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at its next meeting.

6. Manuals (10:20-10:50)

A. Maria Belenky, Darrell Frogg and Suzanne Coyne reviewed conforming revisions to Manual 10: Pre-Scheduling Operations, Manual 11: Energy & Ancillary Services Market Operations, Manual 14D: Generator Operational Requirements, Manual 21B: PJM Rules and Procedures for Determination of Generating Capability, Manual 27: Open Access Transmission Tariff Accounting, and Manual 28: Operating Agreement Accounting addressing market rules around hybrid resources (Docket # ER25-1095). The committee will be asked to endorse the proposed revisions at its next meeting.

B. Pete Langbein reviewed conforming revisions to Manual 18: PJM Capacity Market addressing capacity market rules approved in FERC Dockets: ER25-682, ER25-785, ER24-2995, and ER25-1357. The committee will be asked to endorse the proposed revisions at its next meeting.

C. Nora Embert reviewed proposed Manual 14C: Generation & Transmission Interconnection Facility Construction revisions as a result of its periodic review. The committee will be asked to endorse the proposed revisions at its next meeting.

Informational Posting

7. Operating Reserves Clarification

The PJM/IMM proposal regarding Operating Reserve Clarification Credit Reform was posted with the meeting materials. A Special MRC was scheduled for June 26, 2025 to conduct a page turn of corresponding governing document revisions. The committee will be asked to endorse the proposed solution and corresponding Tariff and OA revisions at its next meeting.
