Administration

1. Stu Bresler and David Anders welcomed stakeholders and provided the Anti-trust, Code of Conduct, and Meeting Participation announcements.

Consent Agenda

Items A through E were **approved/endorsed** by acclamation with no objections and one abstention:

Endorsements

2. Operating Reserves Clarification

Lisa Morelli reviewed the PJM/IMM proposal regarding Operating Reserve Clarification Credit Reform. Following discussion, the proposal was **endorsed** in a sector-weighted vote with 4.611 in favor.

3. Manual 14H: New Service Requests Cycle Process Revisions

Michelle Farhat reviewed conforming revisions to Manual 14H: New Service Requests Cycle Process addressing the cycle process and site control modifications in FERC Order in Docket No. ER25-1544. Following discussion, the conforming revisions were **approved** by acclamation with no objections or abstentions.

4. <u>2027/2028 Base Residual Auction (BRA) Installed Reserve Margin (IRM) and Forecast Pool</u> Requirement (FPR)

Josh Bruno provided an update on the 2027/2028 RPM BRA IRM and FPR. Following discussion, the proposal <u>failed</u> at first read in a sector-weighted vote with 3.262 in favor. Same day endorsement will be sought at the Members Committee.

5. Sub-Annual Capacity Market Issue Charge

Jacob Finkel, Commonwealth of Pennsylvania, reviewed a proposed Problem Statement and Issue Charge to address a sub-annual capacity market. He acknowledged posted comments from PJM, and adopted the following additions to the Issue Charge Key Work Activity 2 suggested by PJM:

- Corresponding changes to the Fixed Resource Requirement alternative to align with the subannual capacity market design.
- Corresponding changes to energy and reserve market must offer requirements to align with a sub-annual capacity market design.
- Transition mechanisms necessary to implement a sub-annual capacity market by the desired timeframe.

Sophia Dossin, Middle River Power, proposed and Jacob Finkel accepted, an amendment to add an Expected Deliverable as follows:

The consultant report should also include an addendum addressing written comments and questions from stakeholders, which PJM would solicit and deliver to the consultant prior to the report's completion.

Following discussion, Jacob Finkel provided an updated Issue Charge incorporating the proposed amendments, and also making additional edits to address additional comments from stakeholders. This updated proposed Issue Charge was posted with the materials for the meeting. John Horstman, Dayton Power & Light, proposed and Jacob Finkel accepted an ammedment to strike "external" and insert "potential" in the first sentence in the Issue Content section of the Issue Charge as follows:

PJM and external stakeholders have recognized the potential benefits of a comprehensive subannual capacity market auction structure for grid reliability and efficiency for many years.

The Issue Charge was <u>approved</u> in a sector-weighted vote with 2.829 in favor (N.B.: the threshold for approval for issue charges is simple majority, or a 2.500 sector-weighted vote).

6. <u>Dual Fuel Capacity Definitions</u>

James Davis, Dominion, reviewed a proposed Problem Statement, Issue Charge and proposed solution addressing modifications to the Dual Fuel Capacity Definitions contained in the Reliability Assurance Agreement (RAA) to expand the definition of dual fuel resources to encompass dedicated fuel sources that are not strictly "onsite."





Michael Youth, NCEMC, proposed, and James Davis accepted, an amendment to the proposed RAA revisions to add "... (2) *stored offsite and* can be directly ..." in both the Gas Combined Cycle Dual Fuel Class and the Gas Turbine Dual Fuel Class sections.

Following discussion, the Issue Charge was <u>approved</u>, and the proposed solution and corresponding RAA revisions were <u>endorsed</u> as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 by acclamation with no objections or abstentions.

7. Storage Integration (Phase II): Transmission Asset Utilization in Operations

- A. David Anders reviewed a proposed Issue Charge addressing operations utilization for storage as a transmission asset.
- B. Juliet Anderson, Constellation, presented an alternative Issue Charge.
- C. Alex Stern, Exelon, presented an alternative Issue Charge.

Following discussion, the PJM Issue Charge failed in a sector-weighted vote with 2.394 in favor. Alex Stern withdrew the Exelon proposed alternate Issue Charge. The Constellation alternate Issue Charge was **approved** by acclamation with two objections and no abstentions.

Gwen Kelly reviewed a proposed solution addressing a review of RPM seller credit provisions for market participants. The committee will be asked to endorse the proposed solution and corresponding Tariff revisions at its next meeting.
