On behalf of the NC, Jeanine Johnson nominated Robert "Bob" Ethier and Le Xie for three year terms on the Board of Managers.

In accordance with Manual 34: PJM Stakeholder Process, the Members proceeded with the other agenda items while ballots were cast and tallied.

Following the balloting, Bob Ethier and Le Xie were **elected** to three-year terms.

Michele Greening reviewed the nominee to fill an open seat on the Finance Committee as the Transmission Owners sector representative. Following discussion, Jeff Stuchell was **elected** to complete a term as a Transmission Owner Sector representative on the Finance Committee through the end of 2026.

This item was moved to the Consent Agenda as item E.

4. DOE 202c Eddystone Extension

This agenda item was removed, as the MC endorsed/approved the solution proposed by the DOE 202c Senior Task Force as Consent Agenda item E on this agenda.

5. Quadrennial Review

This item was moved to the Consent Agenda as item F.

6. CIR Transfer Efficiency

Jason Shoemaker reviewed FERC's ruling on the CIR Transfer Efficiency package and will review proposed changes PJM will file to mitigate the identified issues.

Erik Heinle proposed an amendment to the proposed Tariff, Part VIII, Subpart J, section 437, Replacement Generation Interconnection Service, revisions to add the following subsections:

- c. "In no event shall the milestone dates exceed three (3) years beyond the planned in-service date.
- d. Nothing in this section, or in the Tariff, prohibits a Replacement Generation Project Developer from seeking a waiver from the Commission or from the Transmission Provider supporting such request at its discretion."

There were no objections to this amendment and therefore it was incorporated into the proposed revisions. Following discussion, the proposed solution and associated draft Tariff revisions were **endorsed** by acclamation with two objections and no abstentions.
