Paul Sotkiewicz, E-Cubed Policy Associates, proposed an amendment to include DR participation and requirements in the energy market. PJM as Issue Charge sponsor declined to accept the amendment.

Following discussion, the proposed Issue Charge was **approved** by acclamation with one objection and no abstentions.
