4. Manual 14B Updates

Julia Spatafore, PJM, provided an update on Manual 14B: PJM Region Transmission Planning Process revisions to reflect how batteries will be dispatched in the RTEP base cases. **The committee approved the Issue Charge and endorsed the solution concept as part of the Quick Fix process outlined in Section 8.8.1 of Manual 34 at this meeting with 2 objections and 0 abstentions. The committee preferred the proposed solution over the status quo with 0 objections and 0 abstentions.**

A. Model Build Activity Update

- RTEP
 - 2026 Series Load Flow
 - PJM's Transmission Modeling group will deliver cases to PJM's Transmission Planning for review by early March.
 - PJM's Transmission Modeling and Transmission Planning departments will then begin review of the RTEP cases.
 - 2026 Series Short Circuit
 - TOs provided feedback on Trial 0 5-year case by February 27th.
 - PJM to provide Trial 1 of the 5-year case by March 6th.
 - TOs to provide Trial 1 feedback by March 13th.
 - PJM to provide Trial 2 of the 5-year case by March 20th.
 - TOs to provide Trial 2 feedback by March 27th.
- MMWG
 - 2025 Series Dynamics
 - PJM updated MMWG SDDB database with additional dynamics data for Trial 2.
 - PJM provided idevs for dynamic corrections to PowerTech for Trial 2 and Trail 4.
 - PJM will open the annual Gen Model window for Generation Owner data on May 1st. The window will remain open for 45 calendar days, through June 15th.
 - Generator Owners are expected to submit all required data within window through the Gen Model platform.
 - New fields added to Gen Model for the 2026 window for Generator Owners to provide:
 - Factory Acceptance Test (FAT) report for each transformer – PDF upload
 - Protection Information – DYP file upload, applicable only to IBR
 - Conventional generators that do not own any circuit breaker and previously left the breaker/relay section blank are now required to enter protection information.
 - New section added for Generator Owner review:
 - Facility one-line, along with its modeling data (.idv/.raw)
 - Generator Owners are now able to select between 3 types of cooling – Air, Gas, and Liquid; previously it was set to Gas Cooling only
