1. Megan Heater, PJM, called the meeting to order. Nicole Bugay, PJM, reviewed the Anti-Trust, Code of Conduct, Media Participation Guidelines, and the Webex and In-Person Meeting Participation Guidelines.
2. Nicole Bugay, PJM, reviewed and the committee approved the draft minutes from August 4, 2026 Planning Committee meeting with 0 objections.

3. Fuel Switching for Projects with GIA
 - A. Christina Catalano, PJM, provided pre-approval education regarding post-agreement fuel changes.
 - B. Justin Radl, Invenergy, discussed a Fuel Switch Problem Statement and Issue Charge. **The committee approved the Issue Charge with 87 (60.4%) in favor, 57 (39.6%) opposed, and 12 abstentions.**
4. Manual 21B Periodic Review

Joshua Bruno, PJM, provided updates on Manual 21B: PJM Rules and Procedures for Determination of Generating Capability as part of its periodic review. Meg Tubridy, Cornerstone Gas, motioned to defer the vote to the next PC meeting and John Prunkl, Morris Cogeneration, seconded. **The committee endorsed the deferral with 134 (87%) in favor, 20 (13%) opposed, and 26 abstentions.**
