Administration (9:00 – 9:05)

Stefan Starkov, PJM, reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and WebEx Participant Identification Requirements.

Minutes from the February 5, 2025 Market Implementation Committee meeting were approved by acclamation with no objections or abstentions.

Endorsements (9:05 –10:15)

1. Manual 11 Periodic Review (9:05 – 9:15)

Joey Tutino, PJM, presented revisions to Manual 11 as part of the periodic review. Voting was delayed to allow for additional clarification on some revisions.

The committee will be asked to endorse the revisions at the next meeting.

2. Long-Lead Commitment and Offer-Capping (9:15 – 9:45)

Phil D'Antonio, PJM, reviewed a problem statement and issue charge regarding Long-Lead Commitment and Offer-Capping.

The committee approved an amended issue charge at this meeting by acclamation with 0 objections and 4 abstentions.

3. Black Start Base Formula Rate (9:45 – 10:15)

Glen Boyle, PJM, reviewed the proposed PJM package.

Joe Bowring, Monitoring Analytics, reviewed the proposed IMM package.

Issue Tracking: Black Start Base Formula Rate

The committee endorsed the PJM Package at this meeting with 232 (95.1%) in favor, 12 (4.9%) opposed, and 5 abstentions. A second vote showed stakeholders preferred the PJM Package over the status quo with 212 (94.6%) in favor, 12 (5.4%) opposed, and 25 abstentions.

The committee did not endorse the IMM Package at this meeting with 27 (11.1%) in favor, 217 (88.9%) opposed, and 5 abstentions. A second vote showed stakeholders did not prefer the IMM Package over the status quo with 26 (10.7%) in favor, 218 (89.3%) opposed, and 5 abstentions.

The PJM Package will move to the Markets & Reliability Committee as the Main Motion with 95.1% support and 94.6% preference over the status quo.

If any of these items are discussed the chair will re-direct the conversation. If the conversation still persists, parties will be asked to leave the meeting or the meeting will be adjourned.

PJM may create audio, video or online recordings of stakeholder meetings for internal and training purposes, and your participation at such meetings indicates your consent to the same.

Participant Identification in Webex:

When logging into the Webex desktop client, please enter your real first and last name as well as a valid email address. Be sure to select the "call me" option. PJM support staff continuously monitors Webex connections during stakeholder meetings. Anonymous users or those using false usernames or emails will be dropped from the teleconference.
