 The committee endorsed the PJM/IMM proposal at this meeting with 113 (53.3%) in favor, 99 (46.7%) opposed, and 17 abstentions. A second vote showed stakeholders preferred the PJM/IMM proposal over the status quo with 112 (53.1%) in favor, 99 (46.9%) opposed, and 16 abstentions. The PJM/IMM proposal will move on to the Markets & Reliability Committee as the Main Motion with 53.3% support and 53.1% preference over the status quo.

Stakeholders are also not allowed to create audio, video or online recordings of PJM meetings. PJM may create audio, video or online recordings of stakeholder meetings for internal and training purposes, and your participation at such meetings indicates your consent to the same.

When logging into the Webex desktop client, please enter your real first and last name as well as a valid email address. Be sure to select the "call me" option. PJM support staff continuously monitors Webex connections during stakeholder meetings. Anonymous users or those using false usernames or emails will be dropped from the teleconference.
