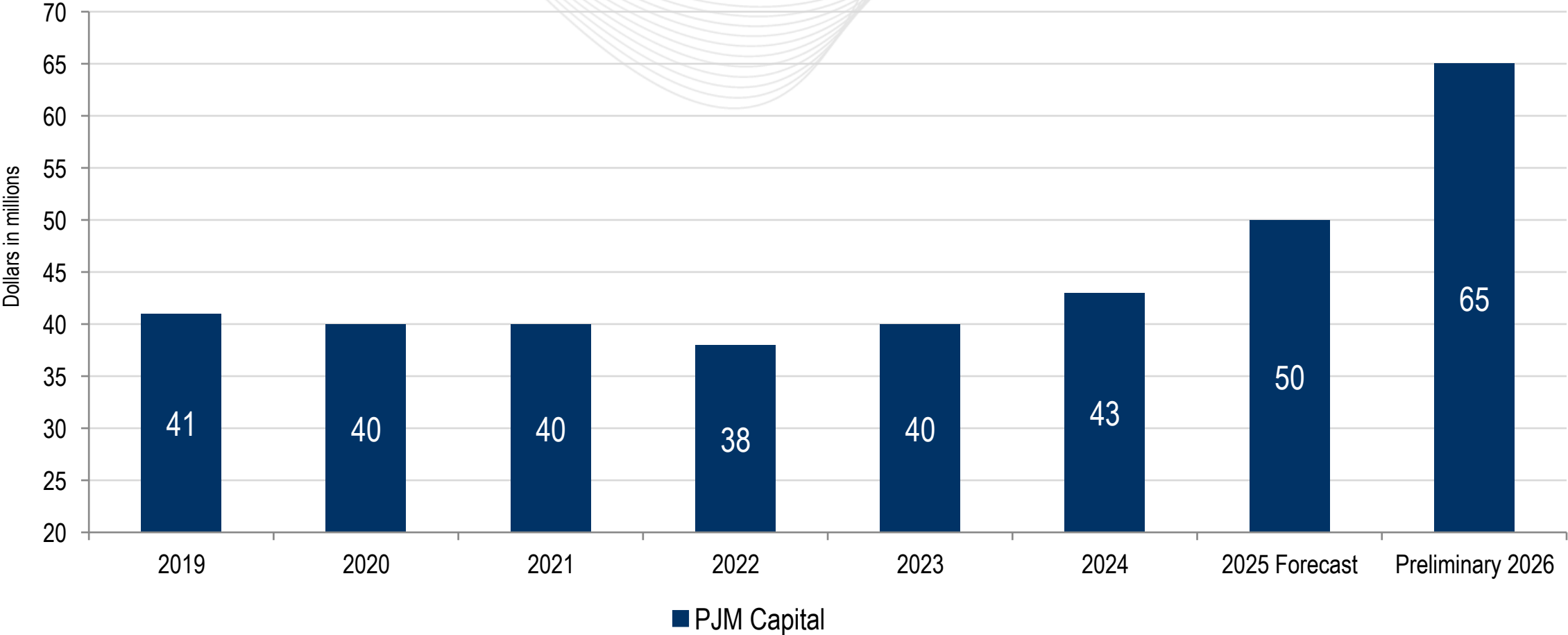
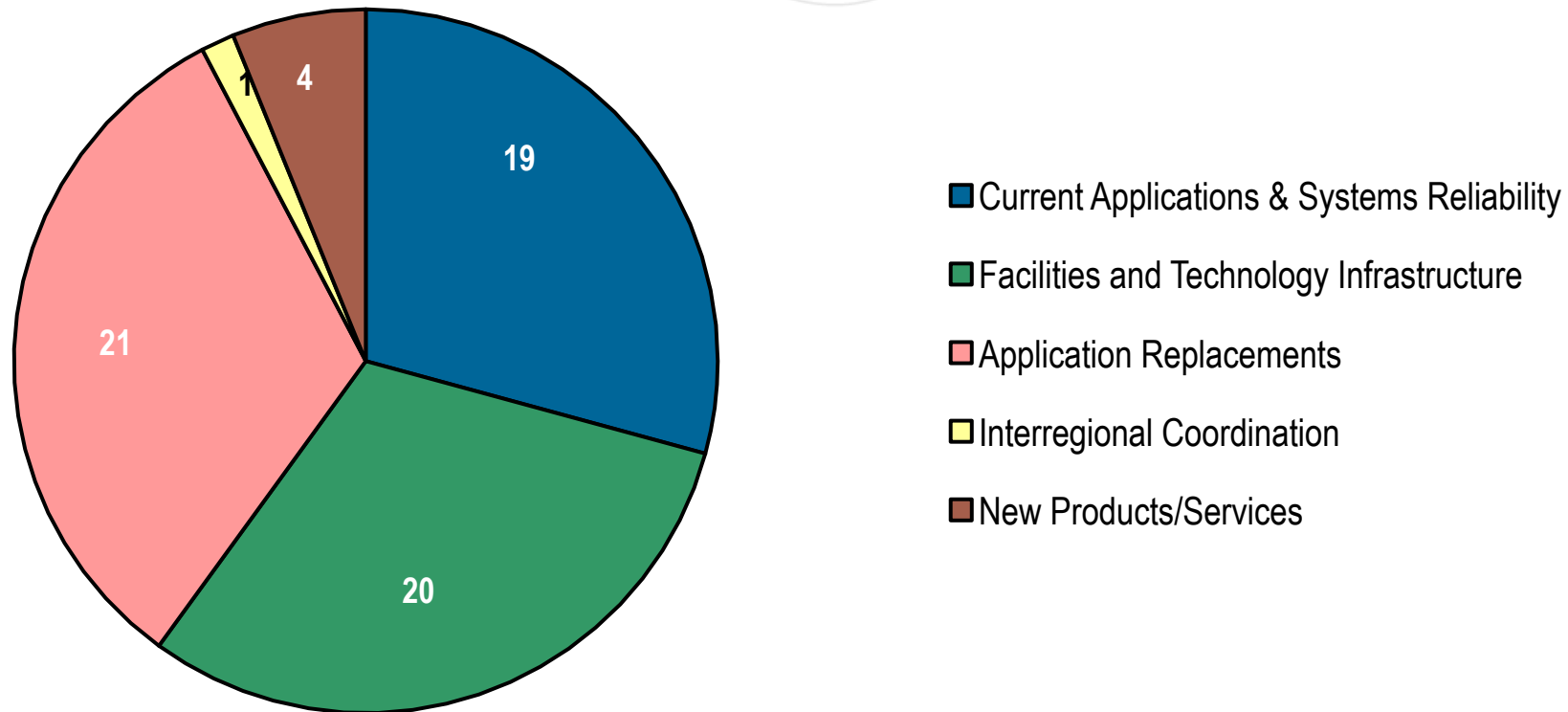

Energy Management Network Application and Training Systems – This project will implement updated architecture for PJM’s Transmission Network Application (TNA) and the Operator/Dispatch Training (OTS/DTS) systems. *Service Category: 9-1 Control Area Services*

Energy Management Model Manager – This project will implement updated architecture for PJM’s Model Manager (IMM) system. *Service Category: 9-1 Control Area Services*

Next Generation Markets Systems (nGEM) – This project is a collaborative project with vendor and ISOs/RTOs to transform the market systems architecture, technology and products. *Service Category: 9-3 Market Support Services*

SAP ERP Refresh – *This project will replace the legacy ERP tool with the newest SAP ERP product. Service Category: 9-5 Management Services*

Market Settlements Billing Refresh – This project will replace an out-of-support application critical to the weekly and monthly billing system. *Service Category: 9-PSI PJM Settlements Inc.*

Governance, Risk and Compliance Tool Replacement – *This project will replace and automate existing compliance tool and manual processes for compliance documentation, as well as improve internal controls and risk assessment capabilities. Service Category: 9-5 Management Services*

New Forecast Model Implementation – *This project will implement a new short-term load forecast model. Service Category: 9-1 Control Area Services*

Dispatcher Application and Reporting Tool Enhancements – This project will create a tool to identify transformers with load tap changers and submission of tap changes providing transmission owners visibility of neighboring non-telemetered tap information. *Service Category: 9-1 Control Area Services*
